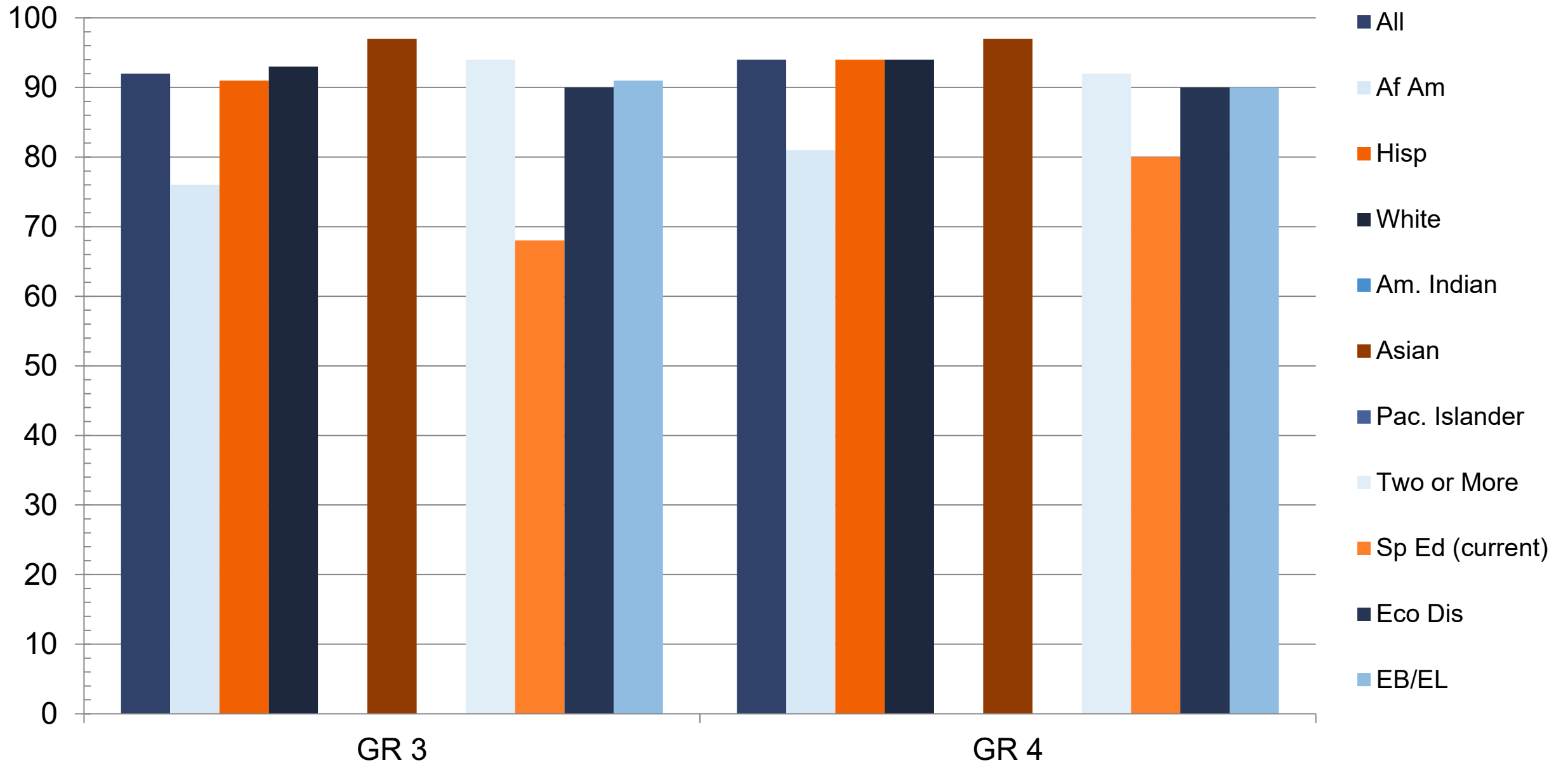

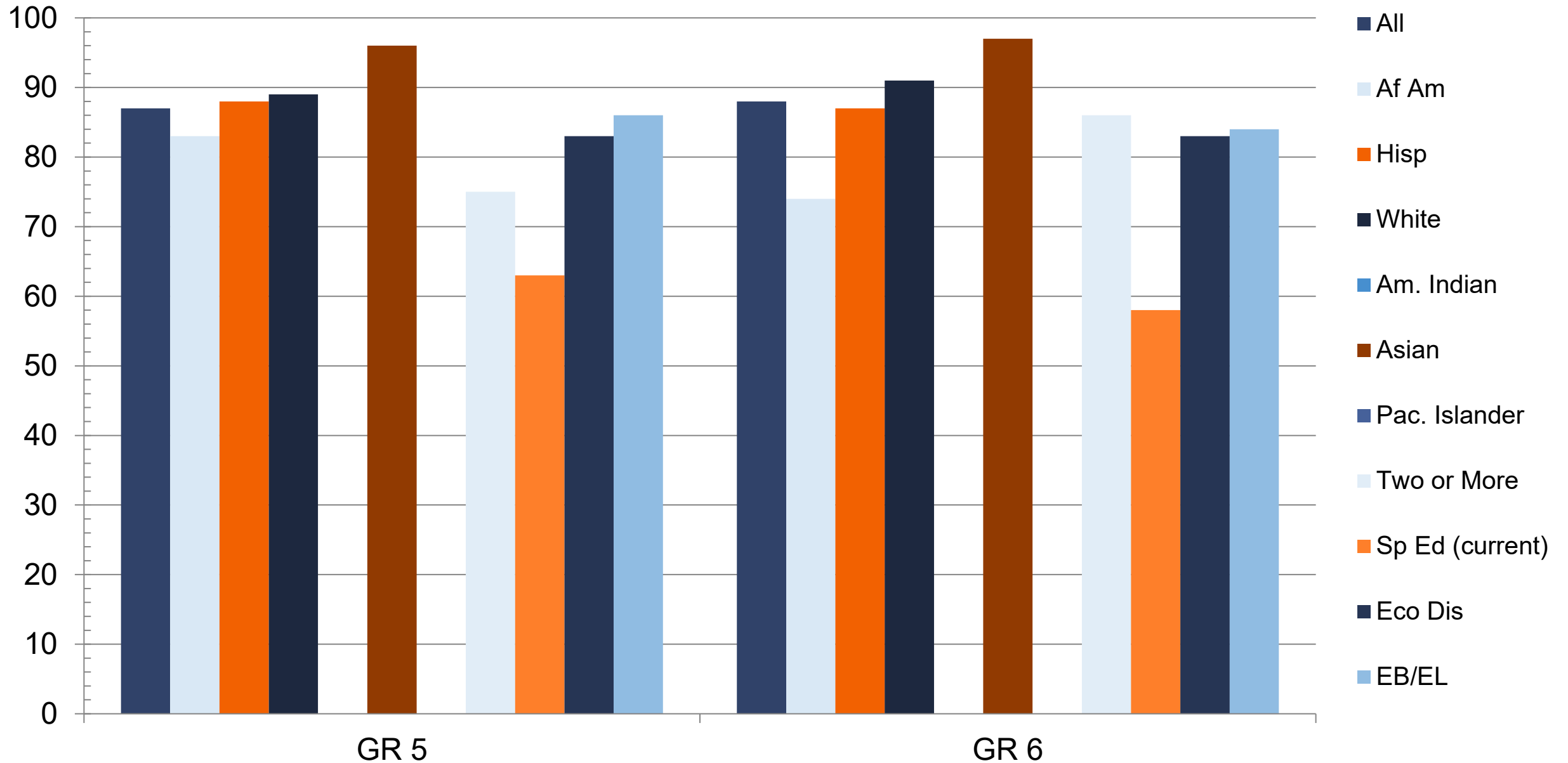
2025 STAAR 3-8 Reading Performance

Percent at Approaches Grade Level or Above



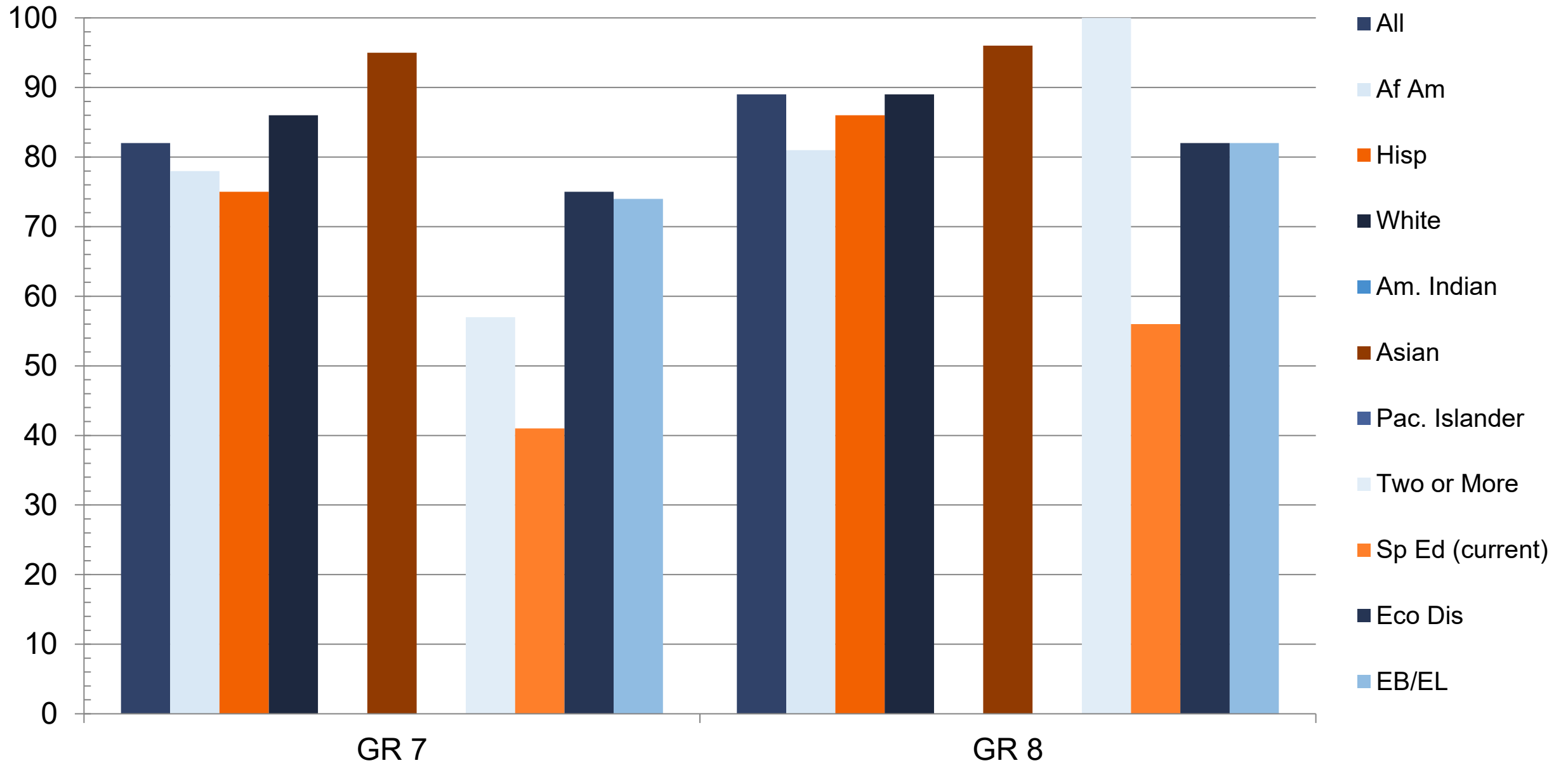

Percent at Approaches Grade Level or Above



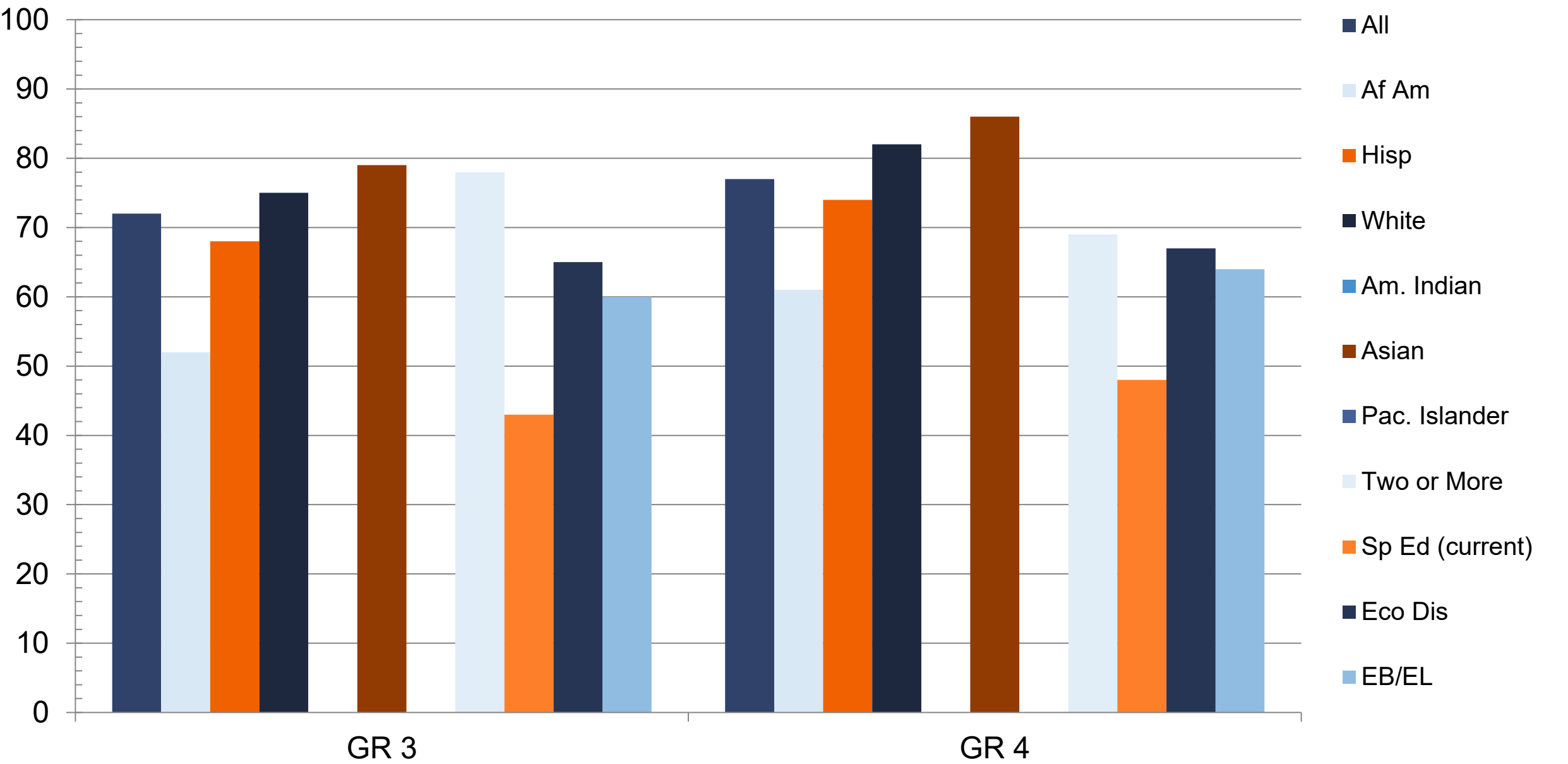

Percent at Approaches Grade Level or Above

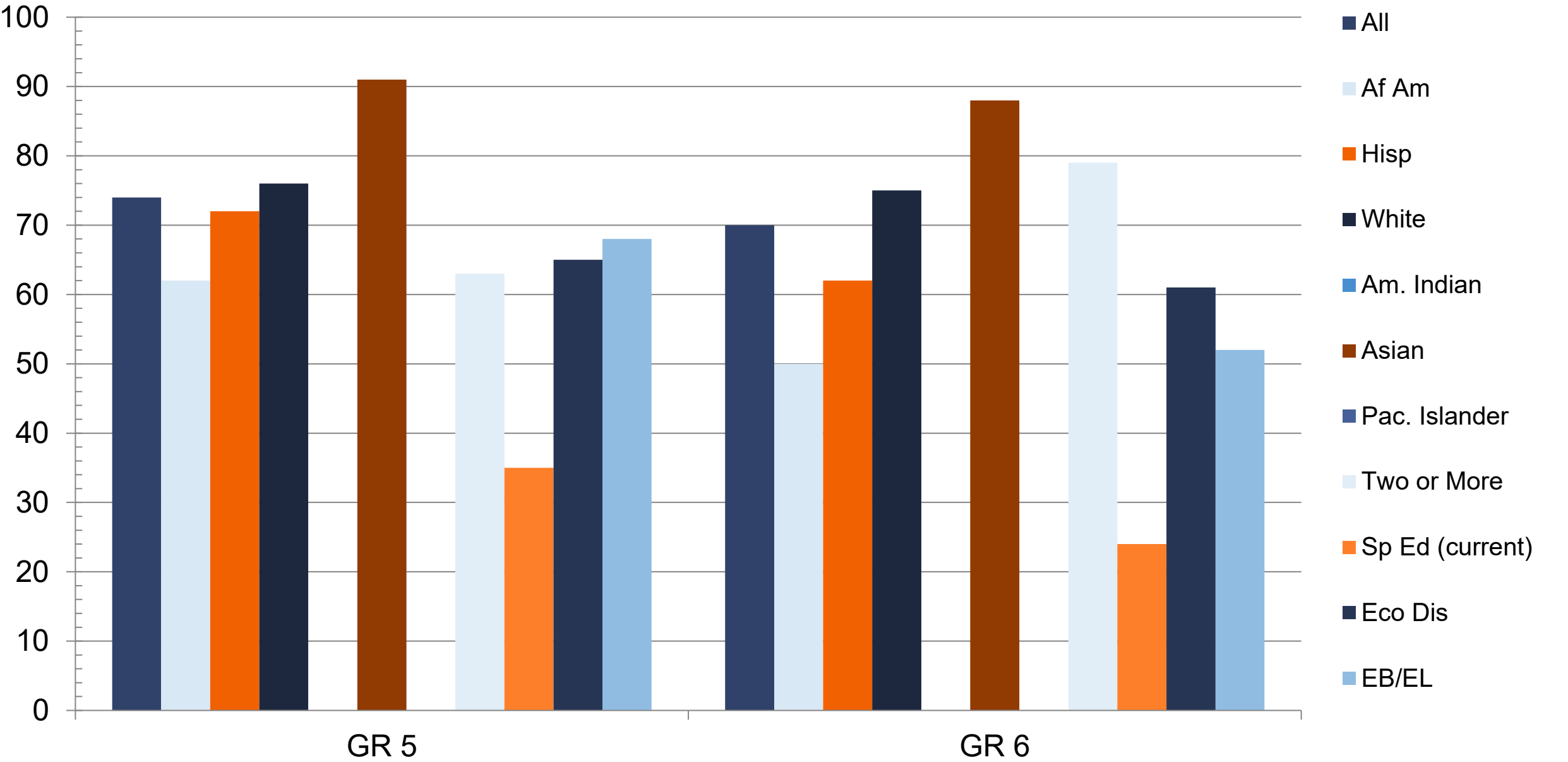

Percent at Meets Grade Level or Above

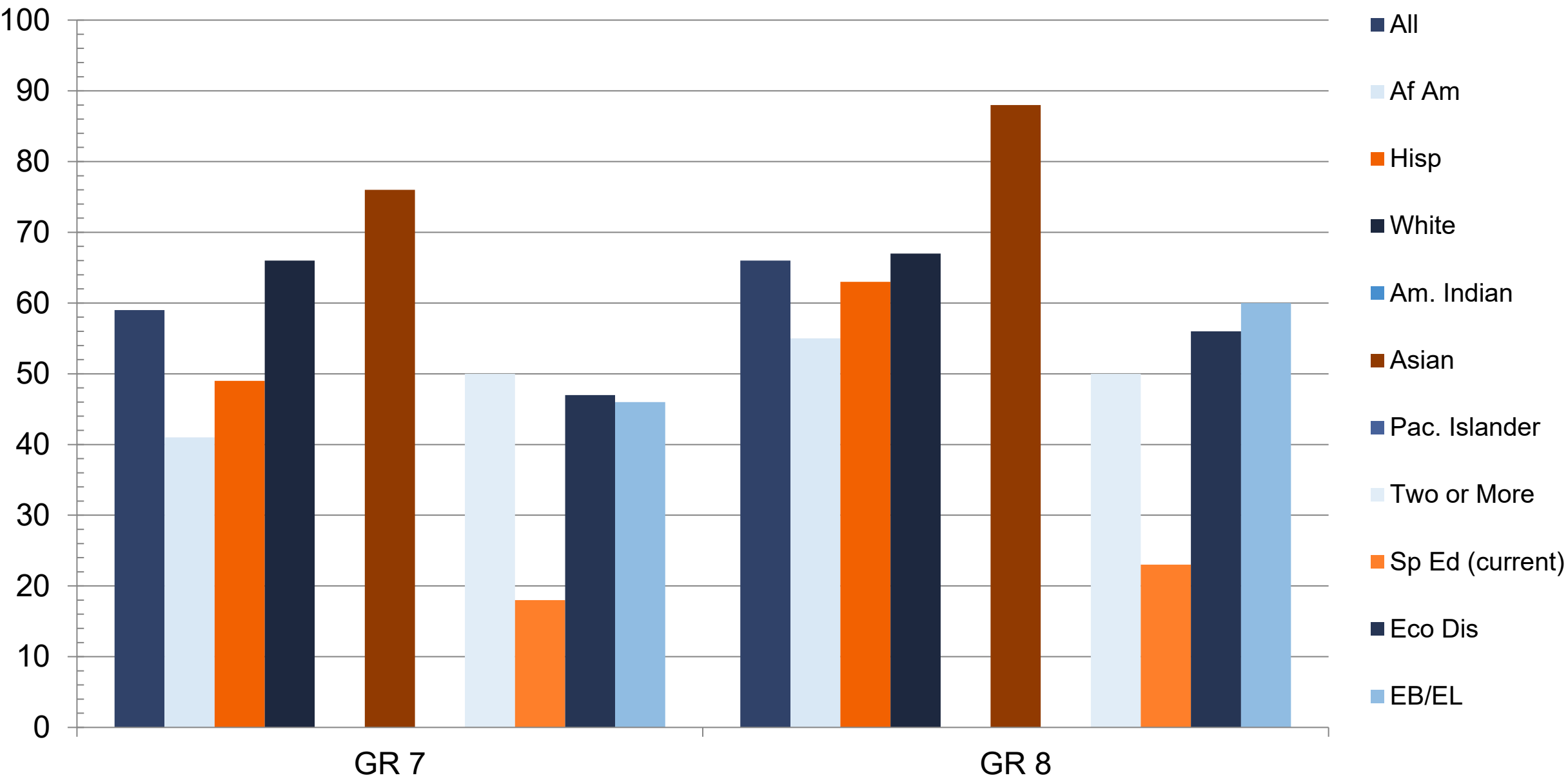

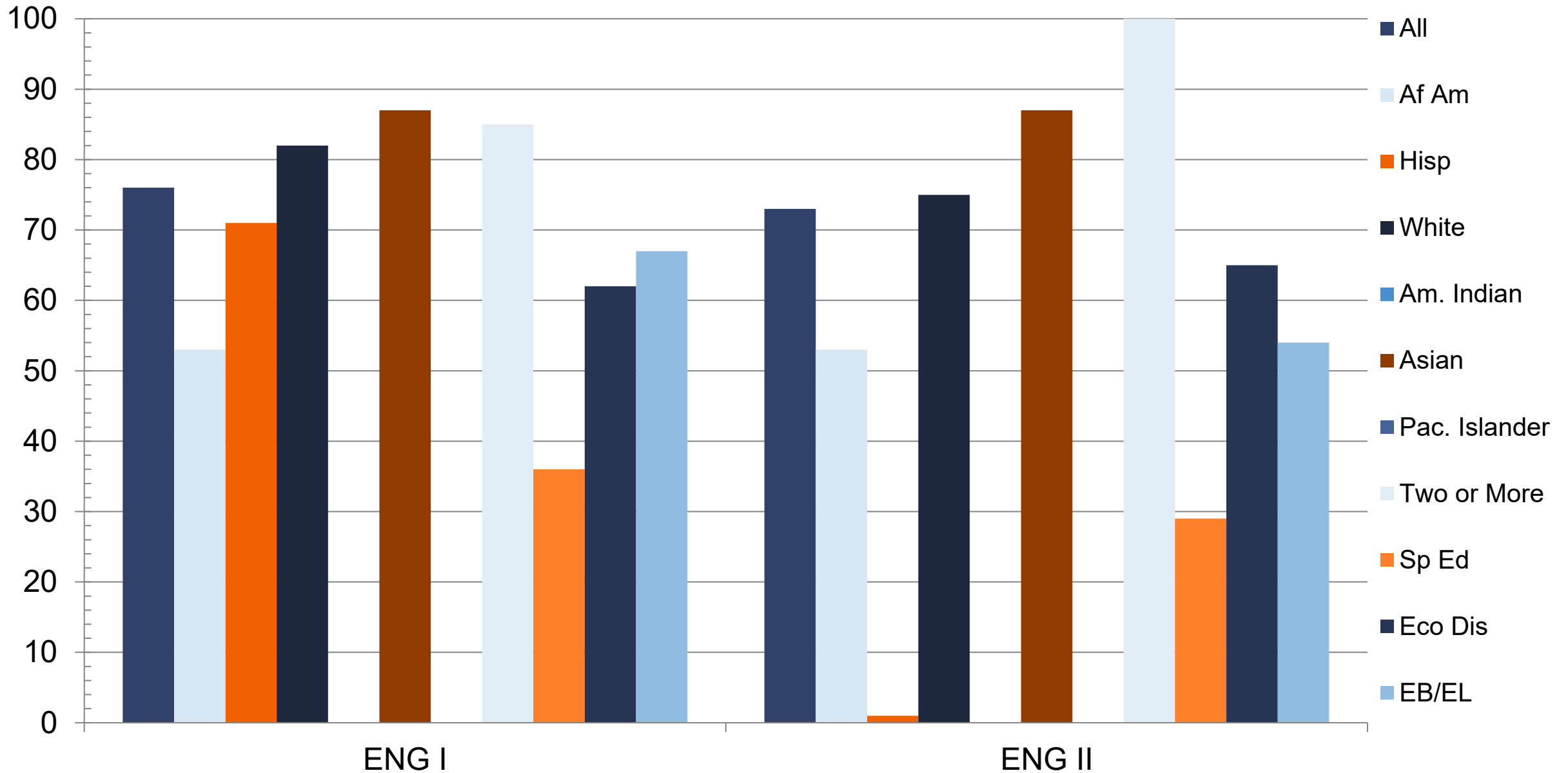
2024 STAAR 3-8 Reading Performance

Percent at Meets Grade Level or Above



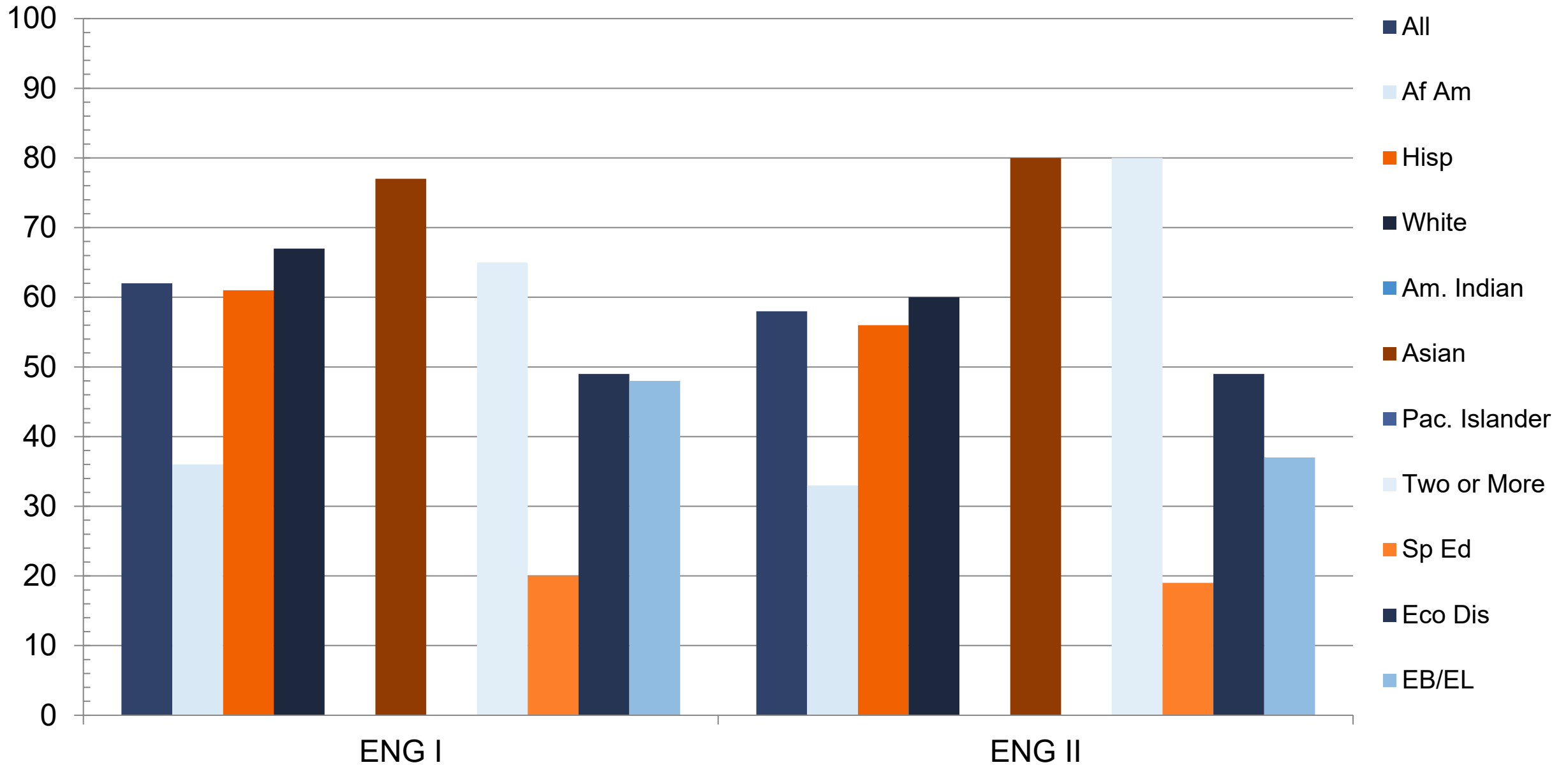
2025 STAAR End-of-Course: English Language Arts

Percent at Approaches Grade Level or Above



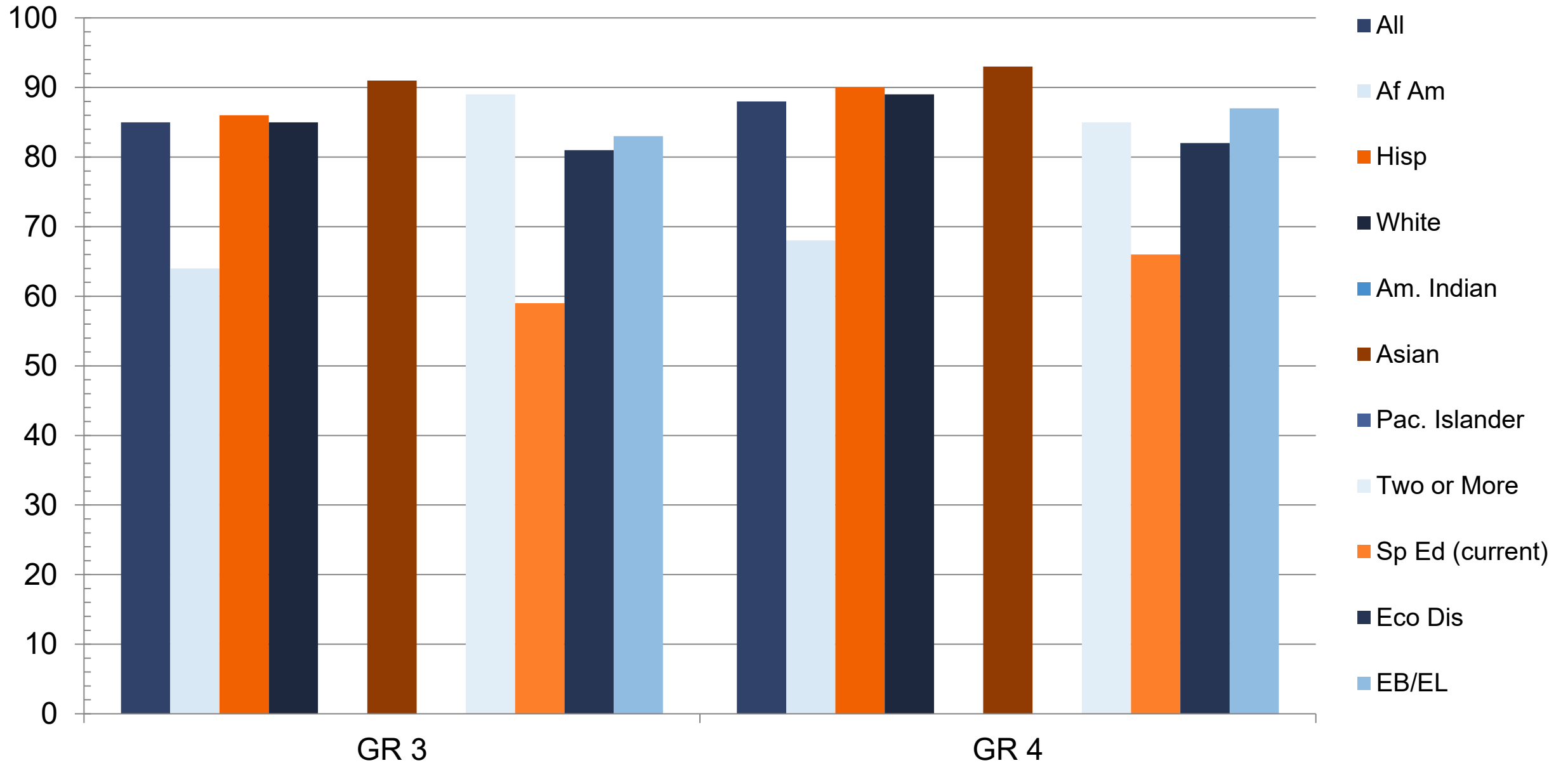

Percent at Meets Grade Level or Above



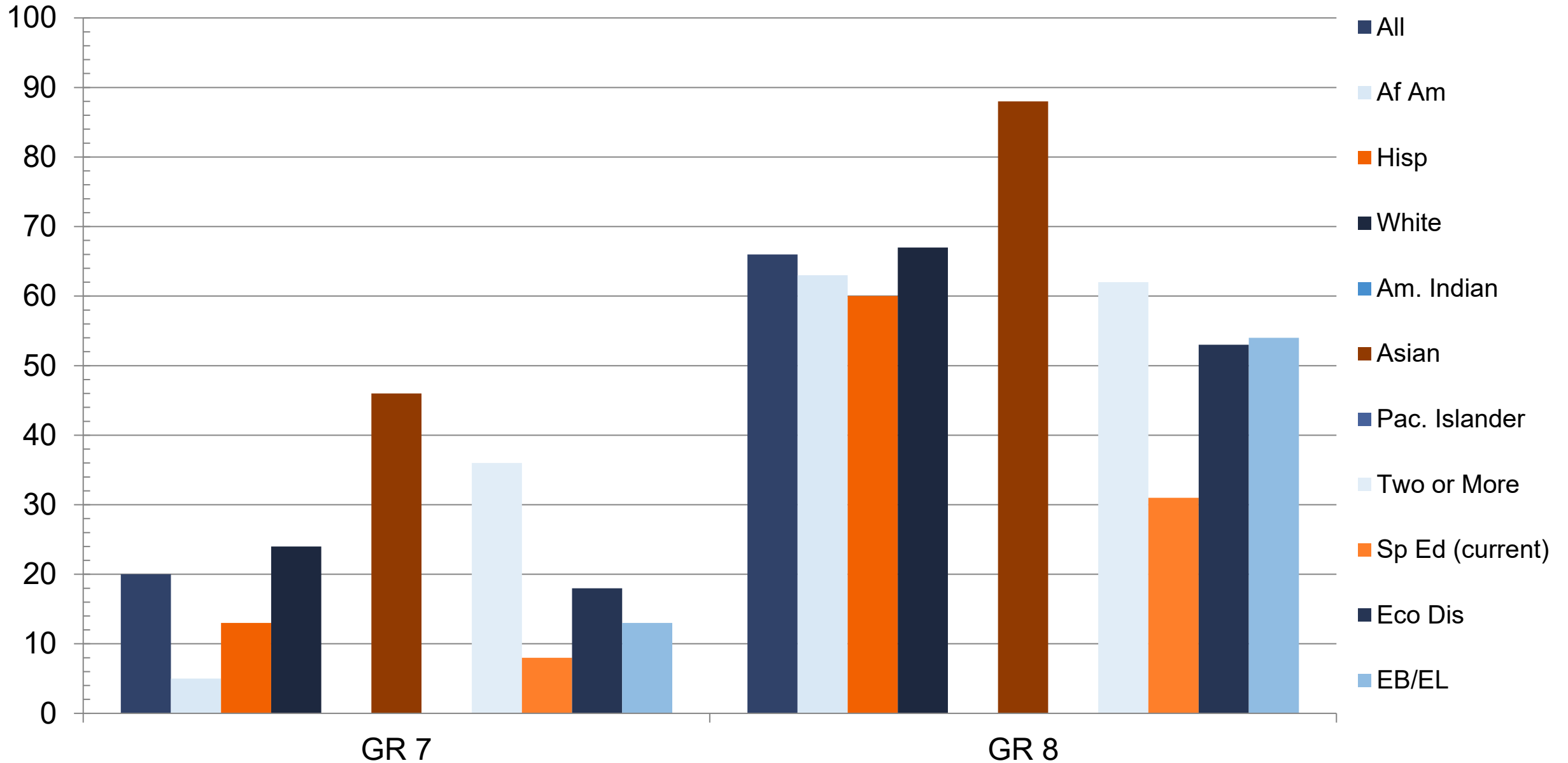

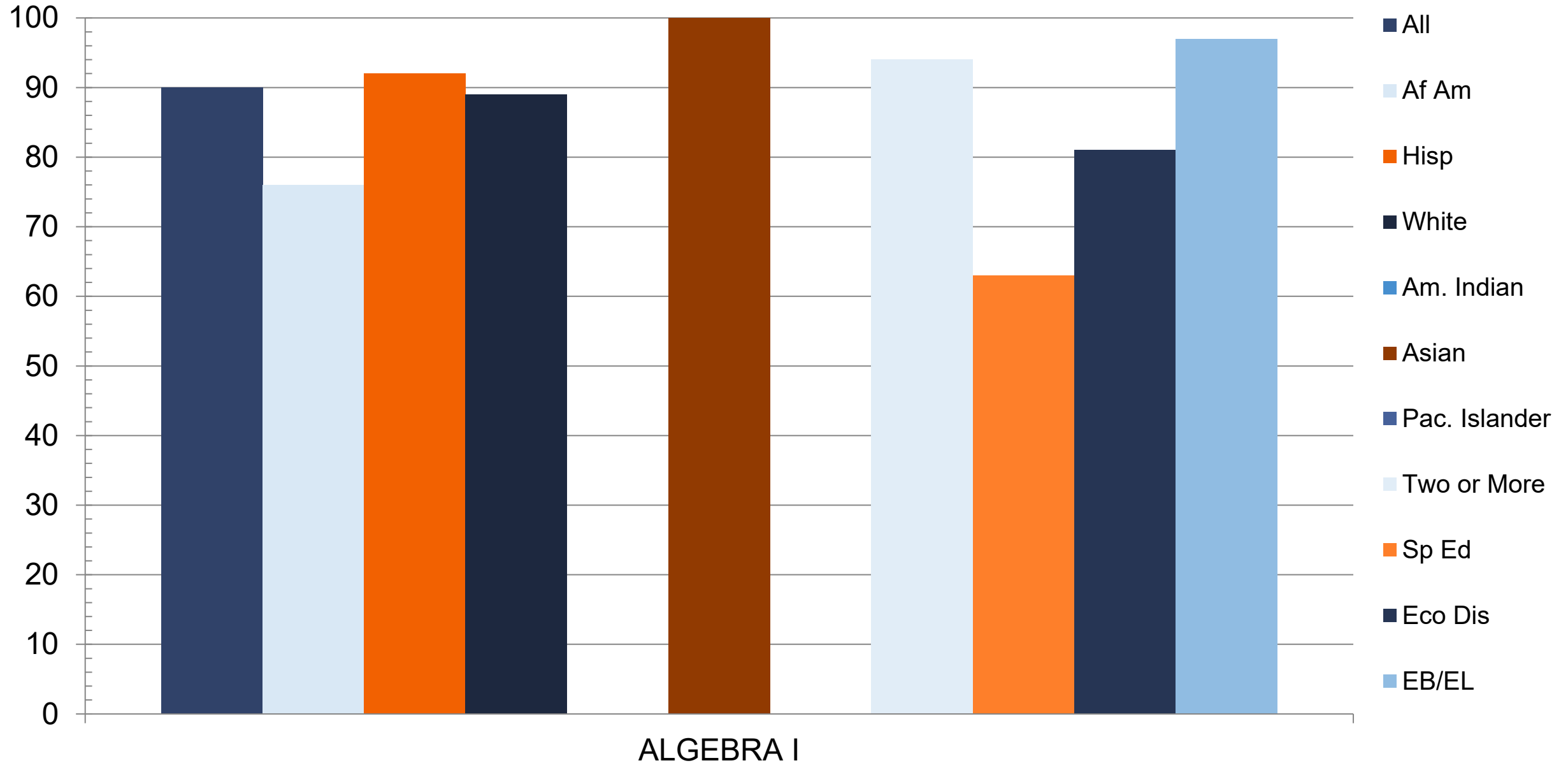

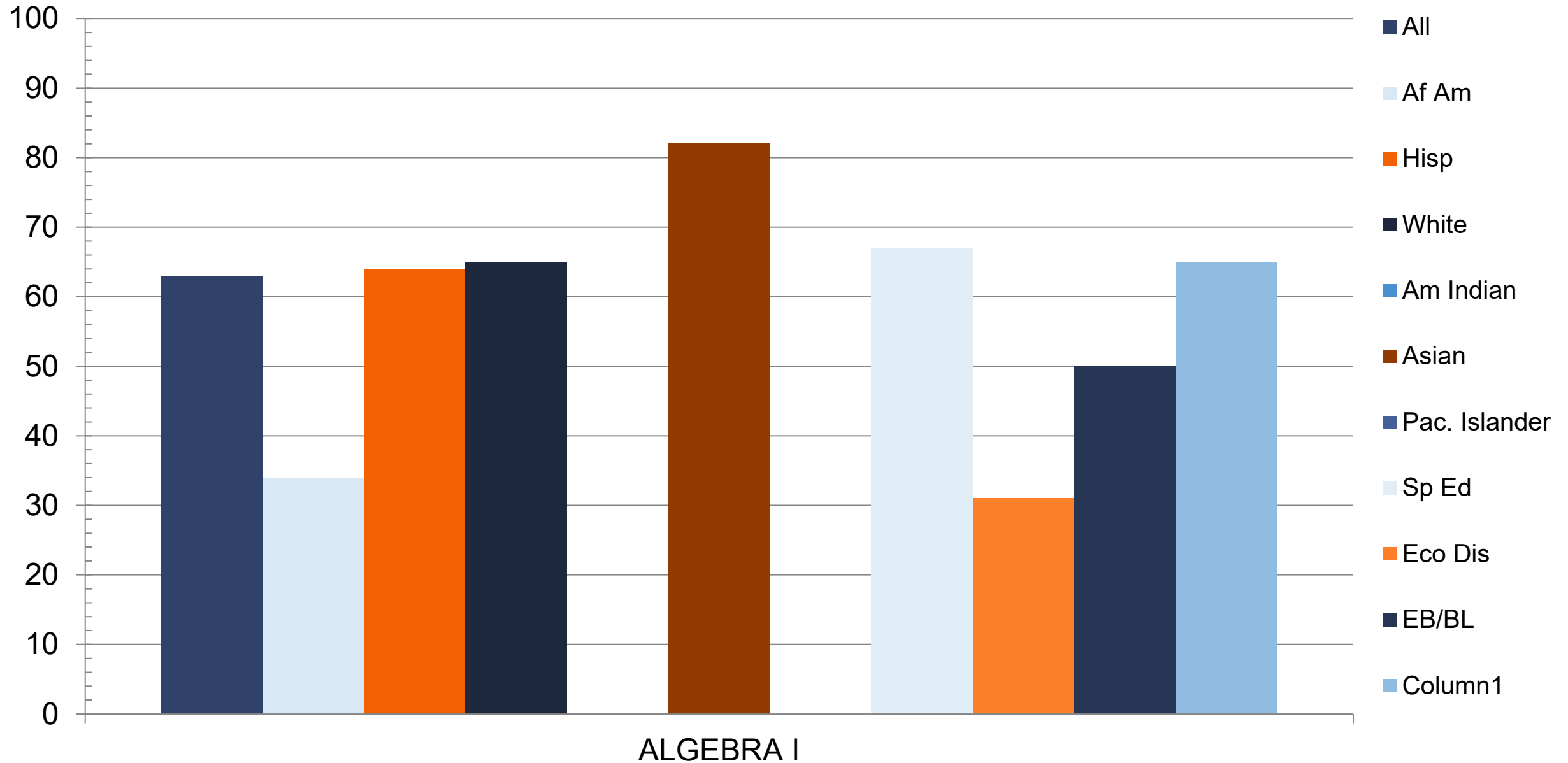

Percent at Approaches Grade Level or Above



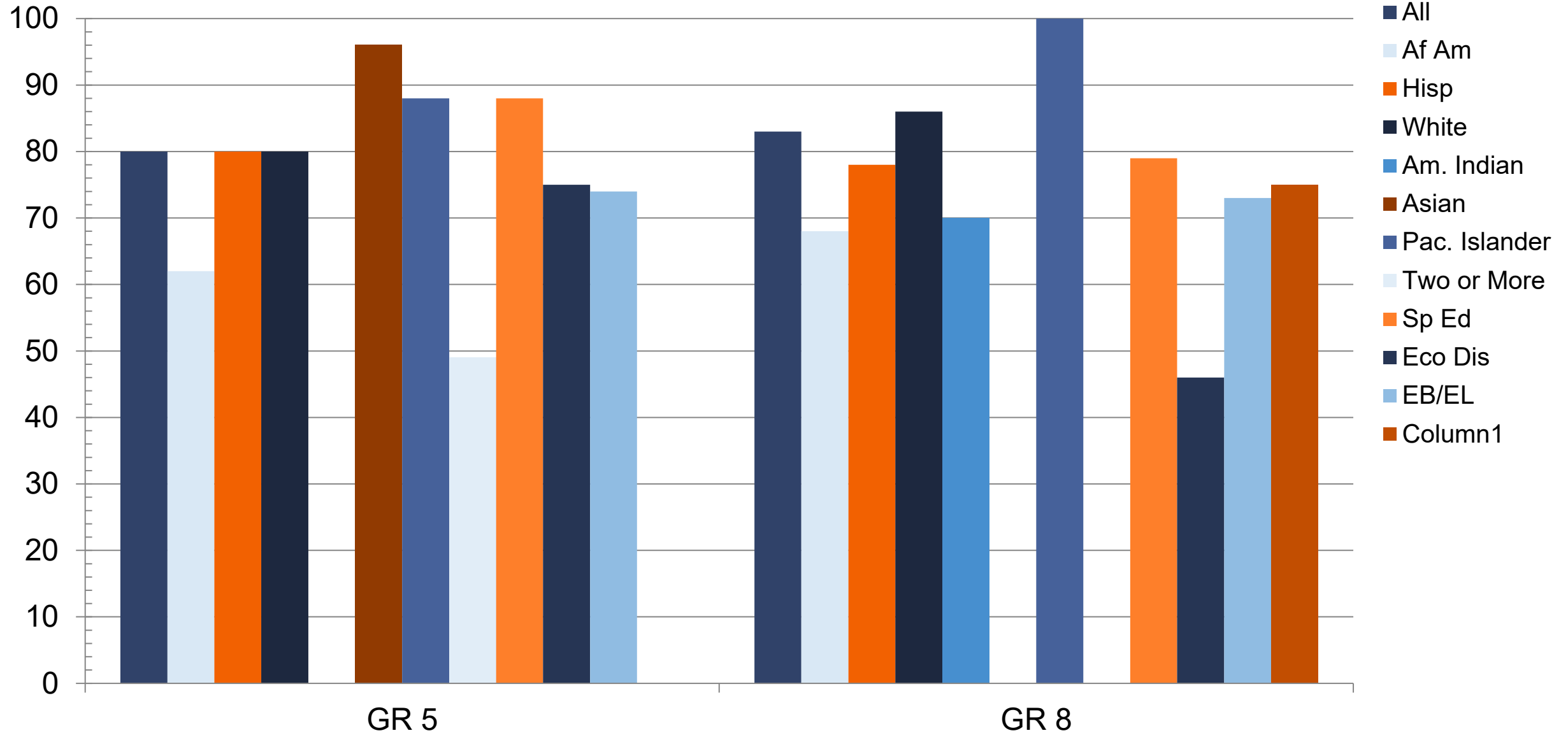

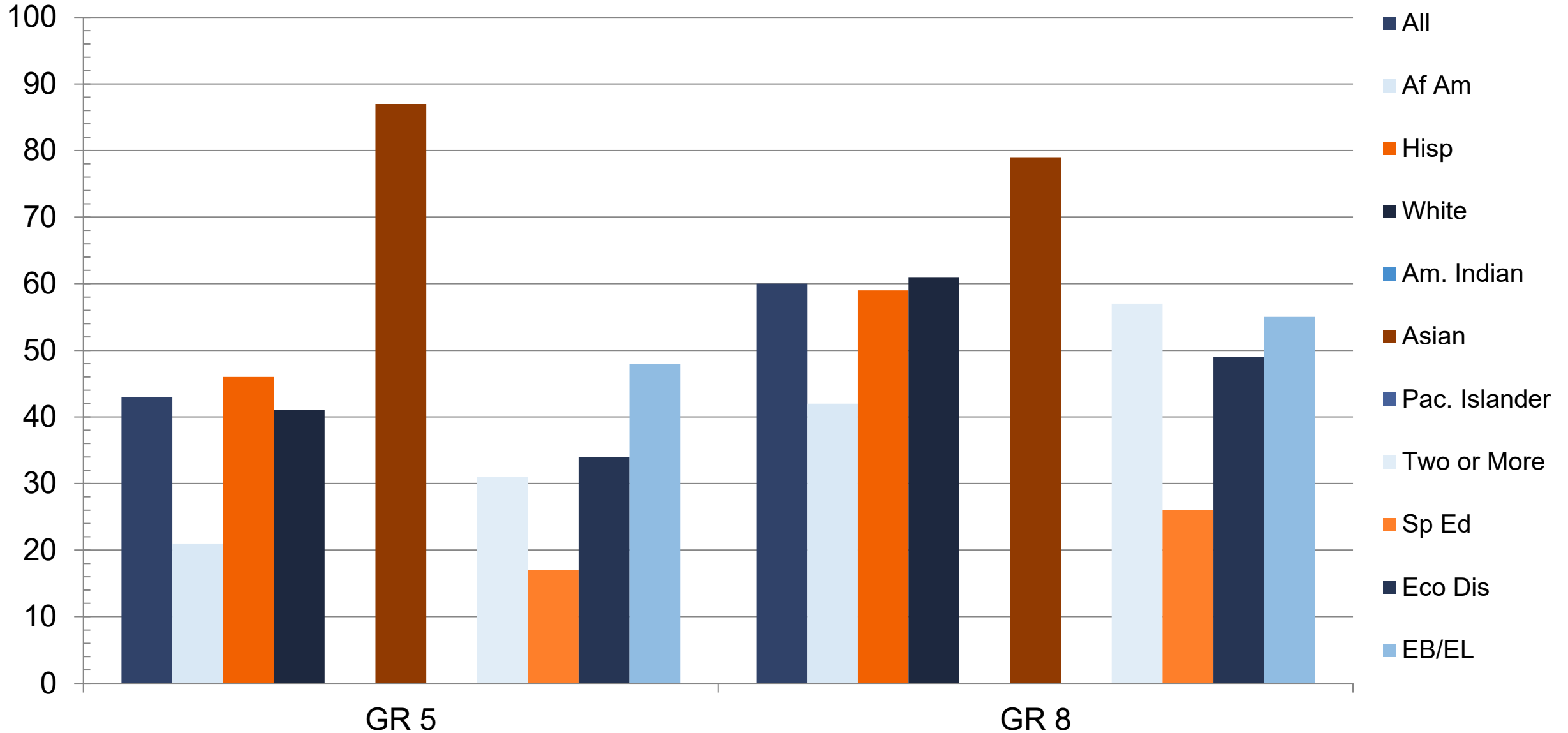

Percent at Approaches Grade Level or Above



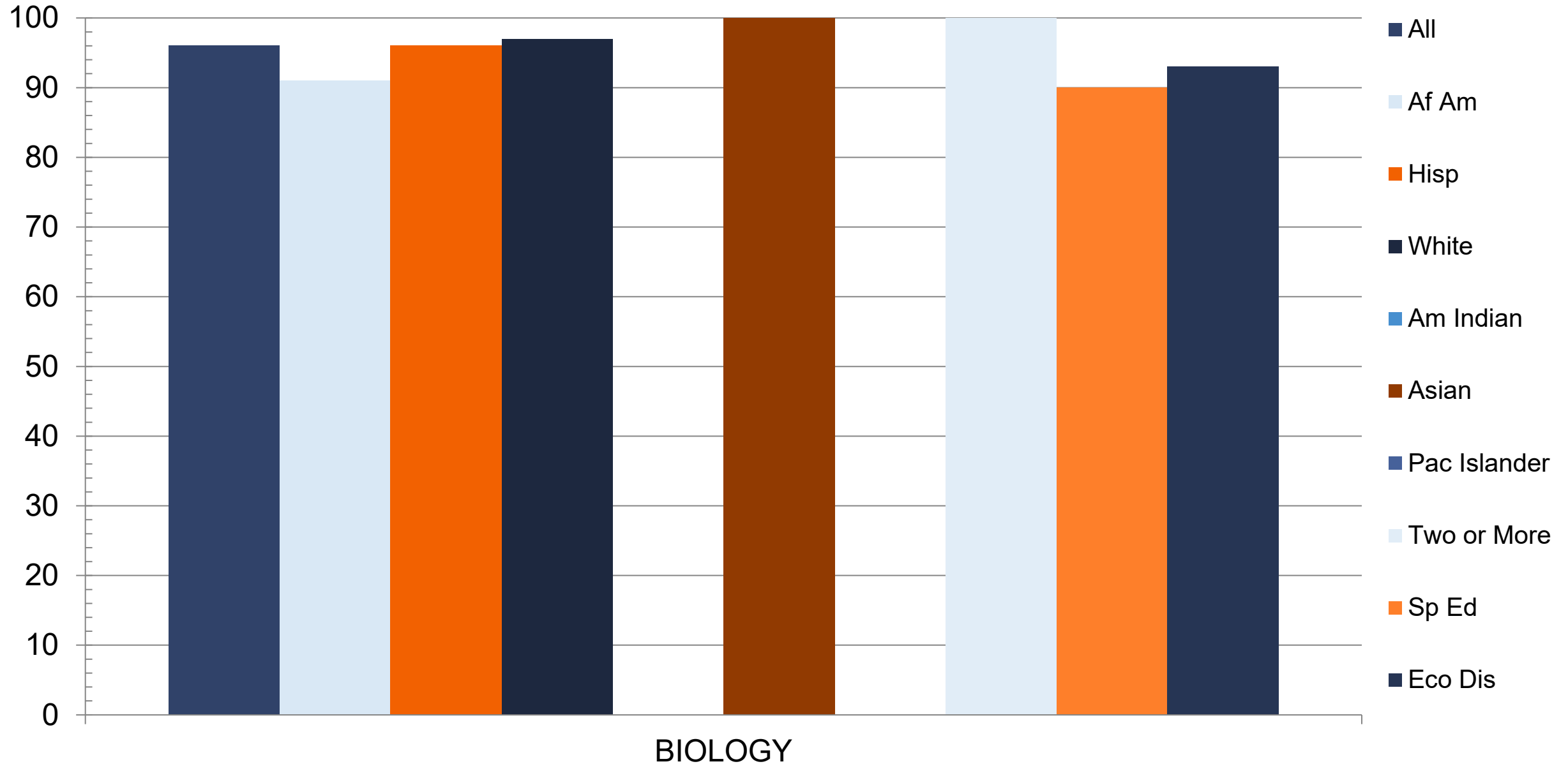

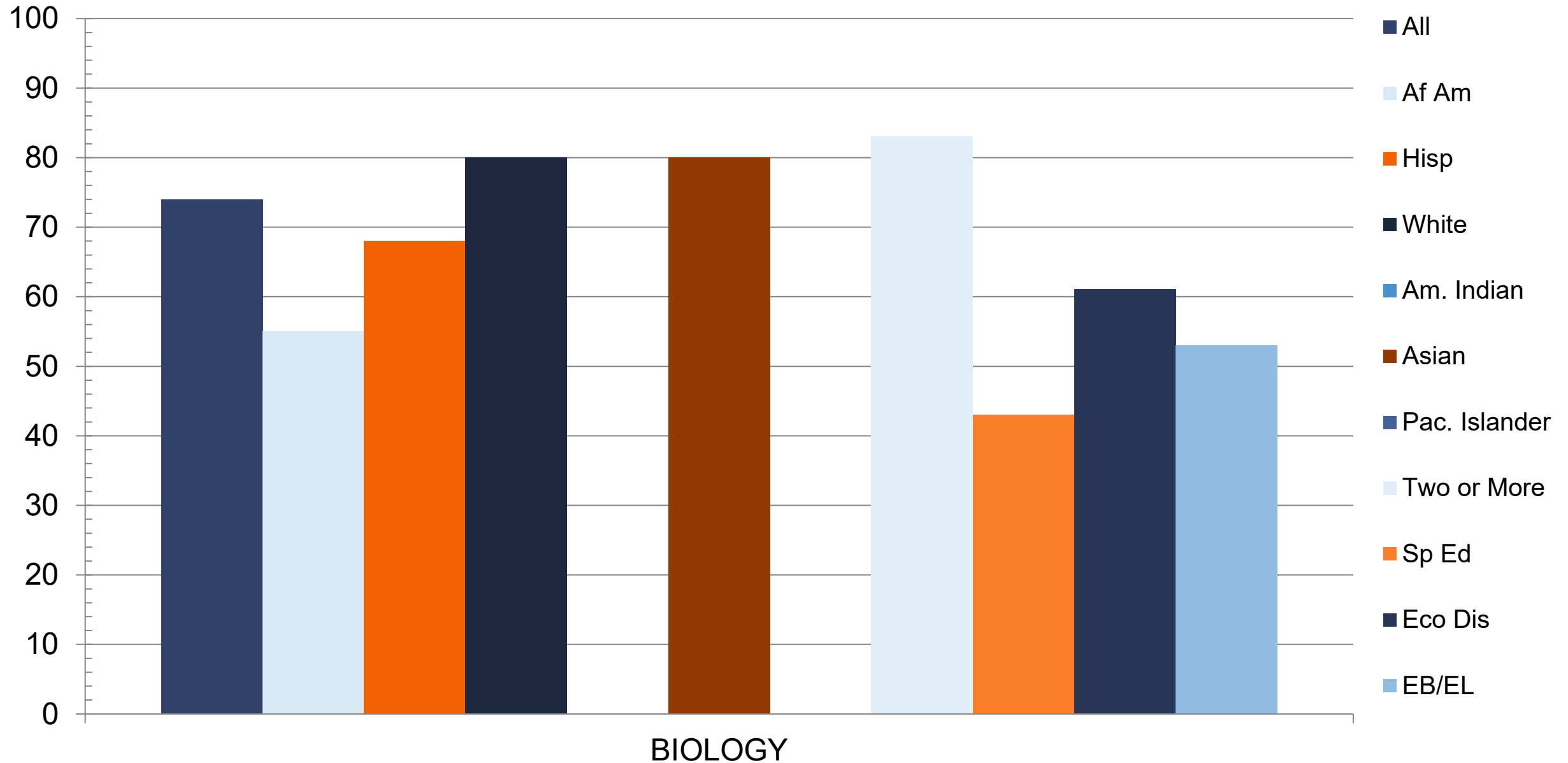

Percent at Approaches Grade Level or Above



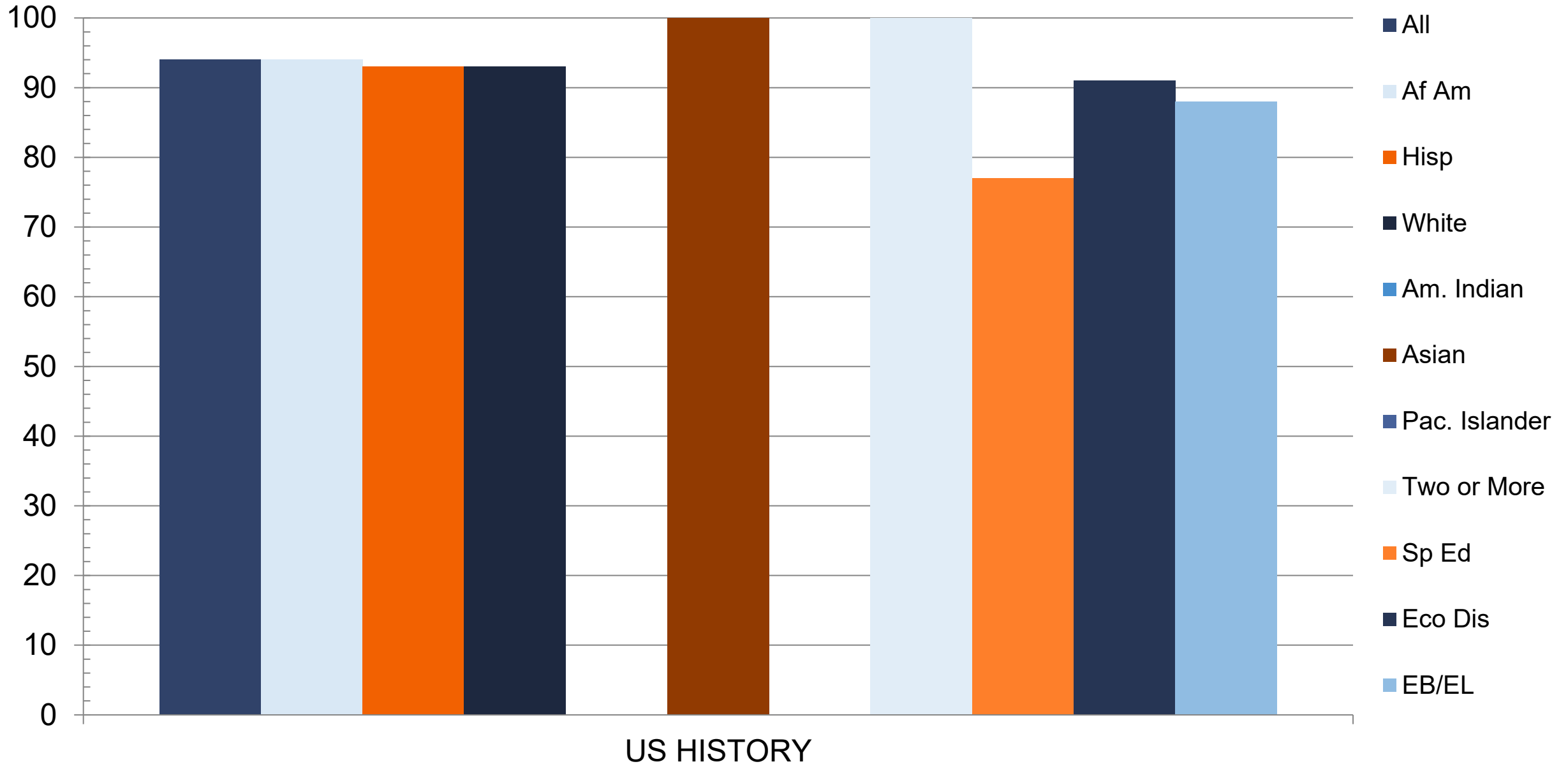

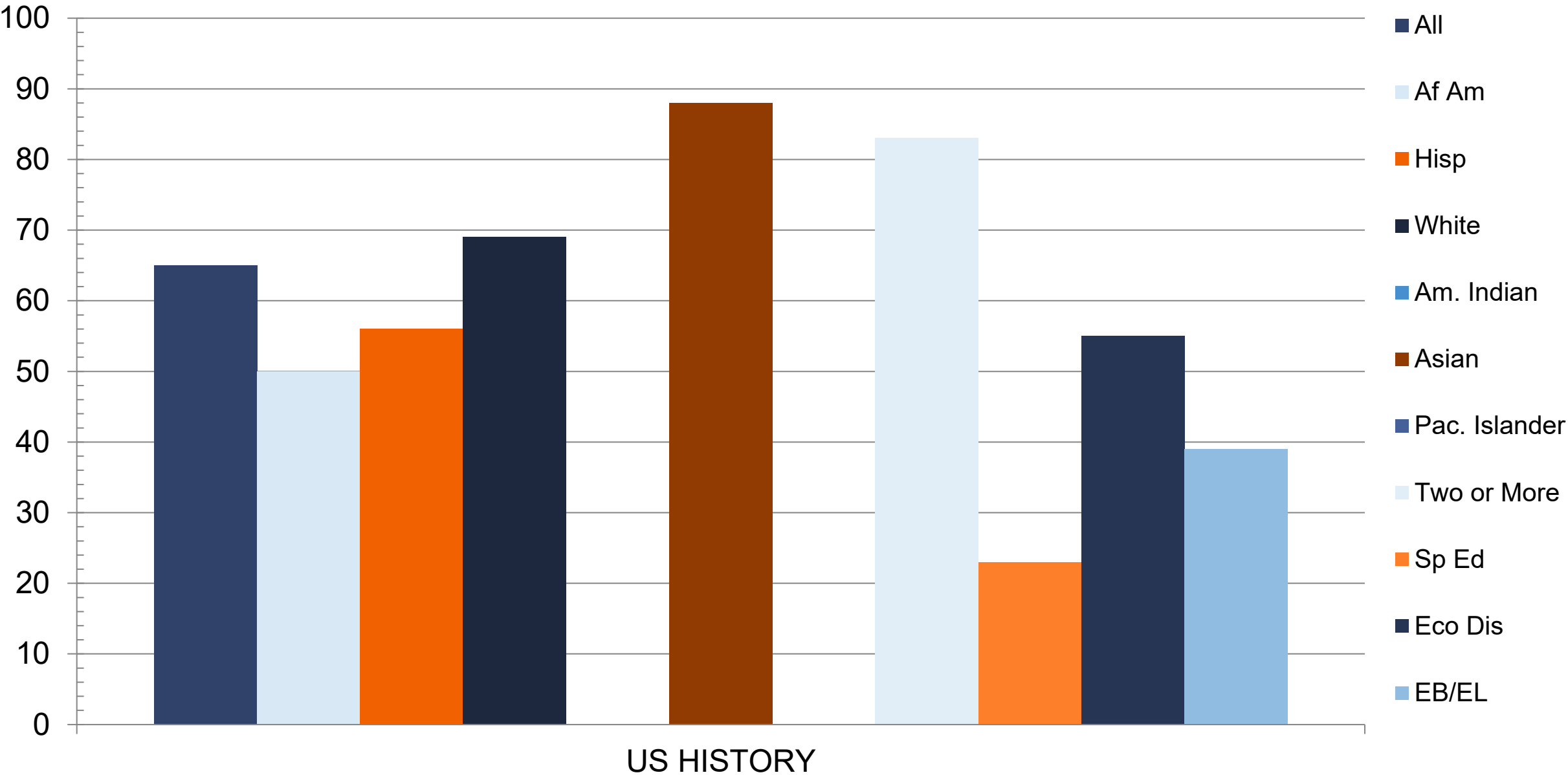

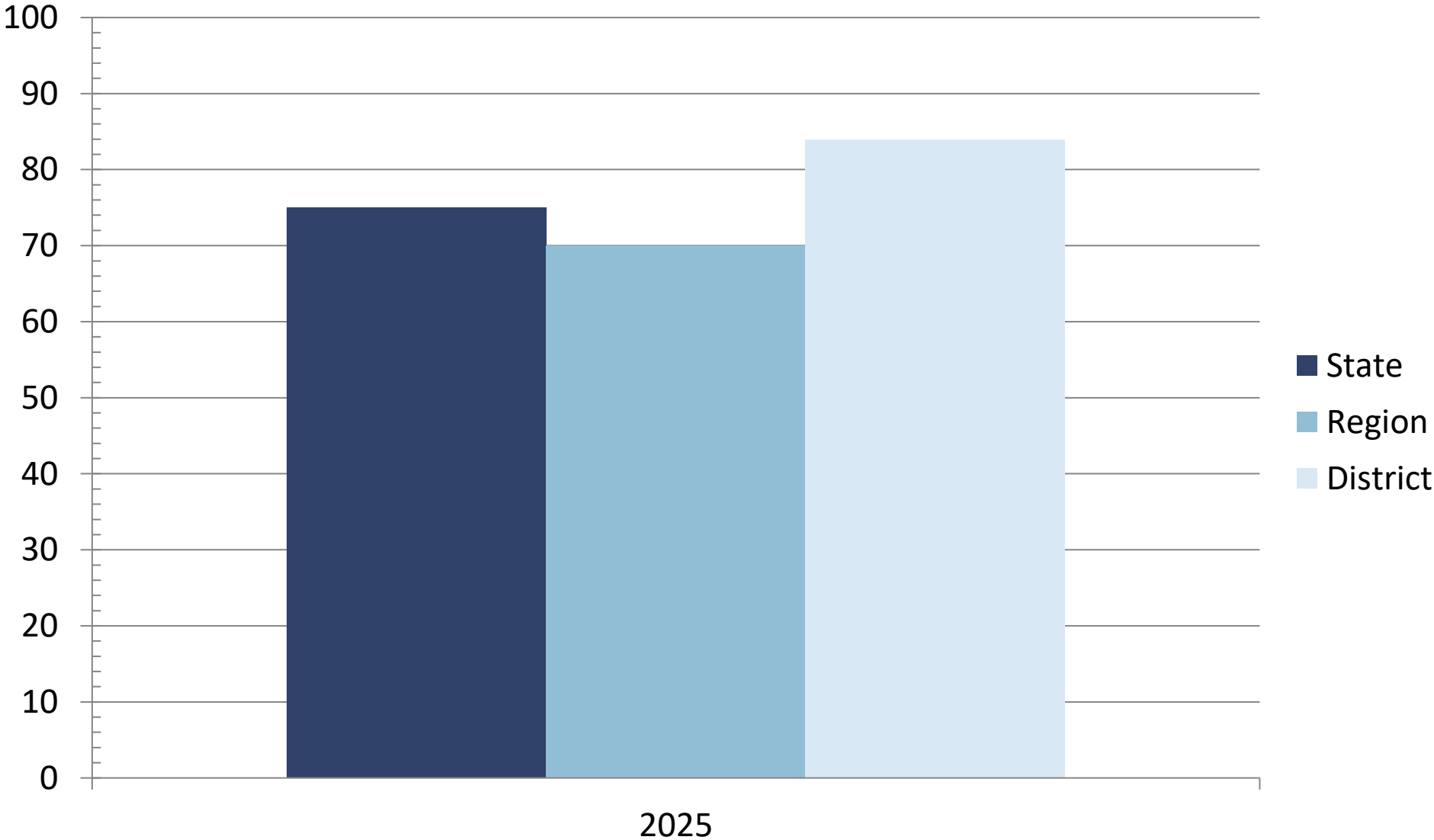

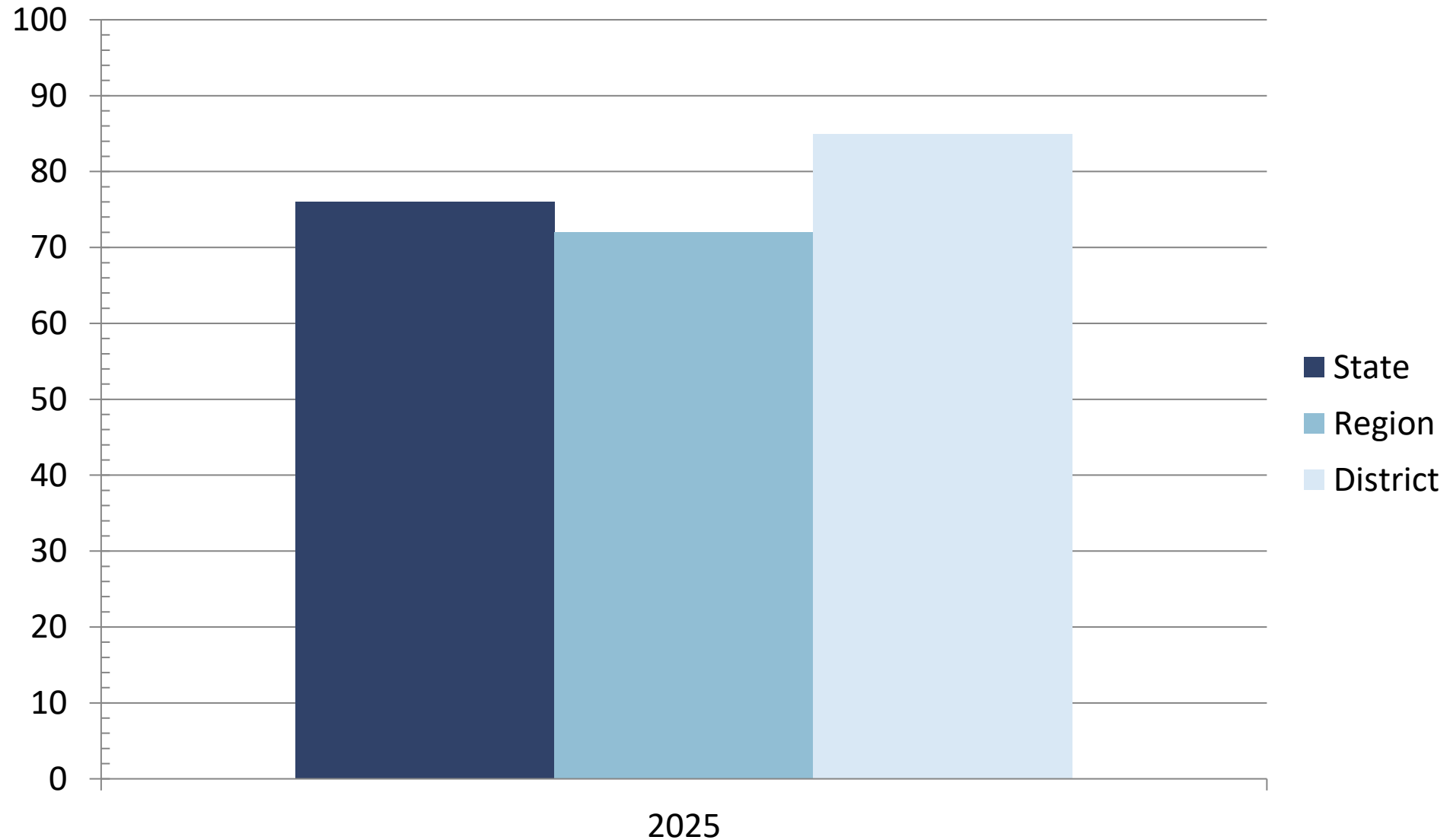
STAAR Percent at Approaches Grade Level or Above All Grades, All Subjects



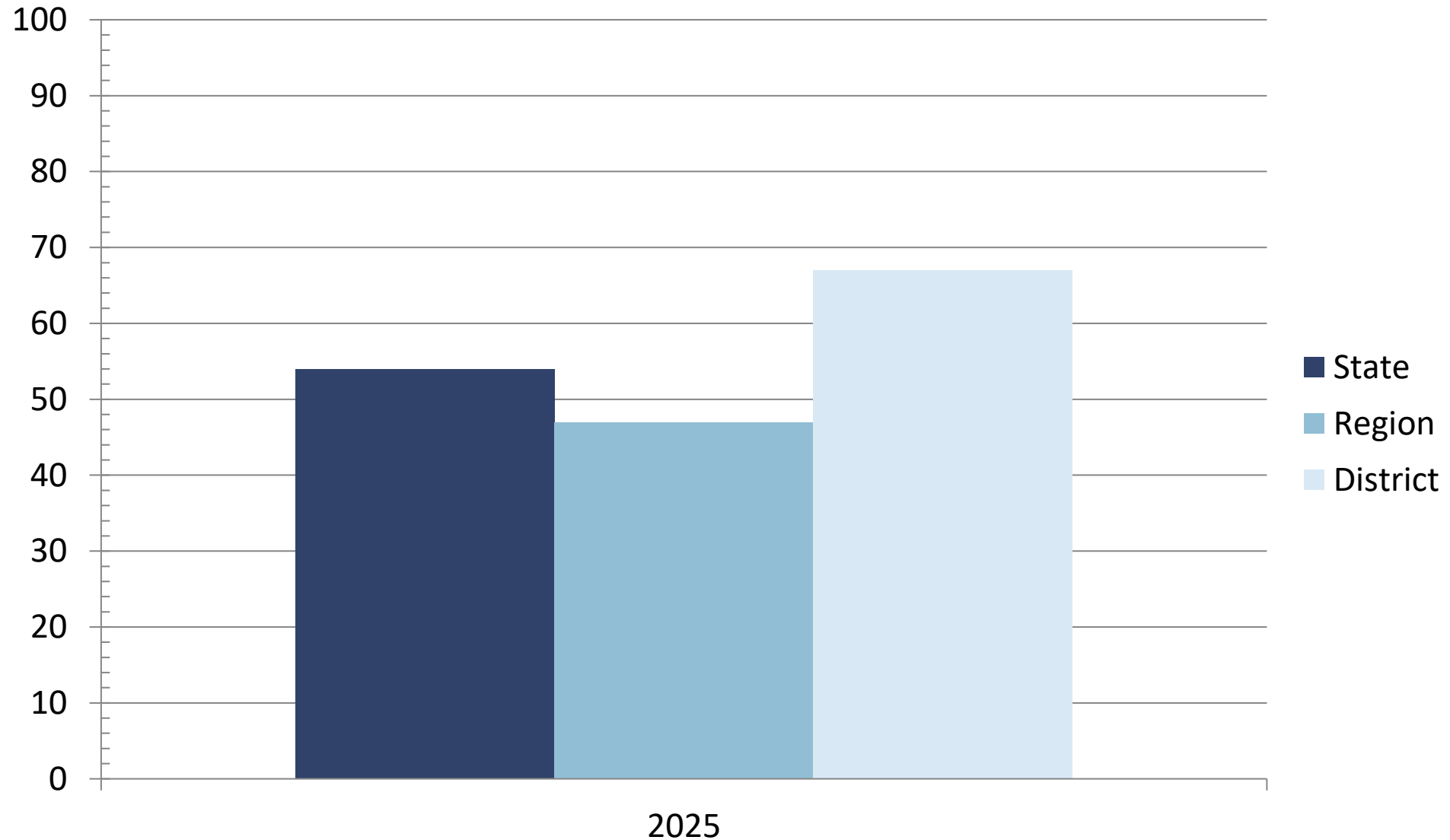

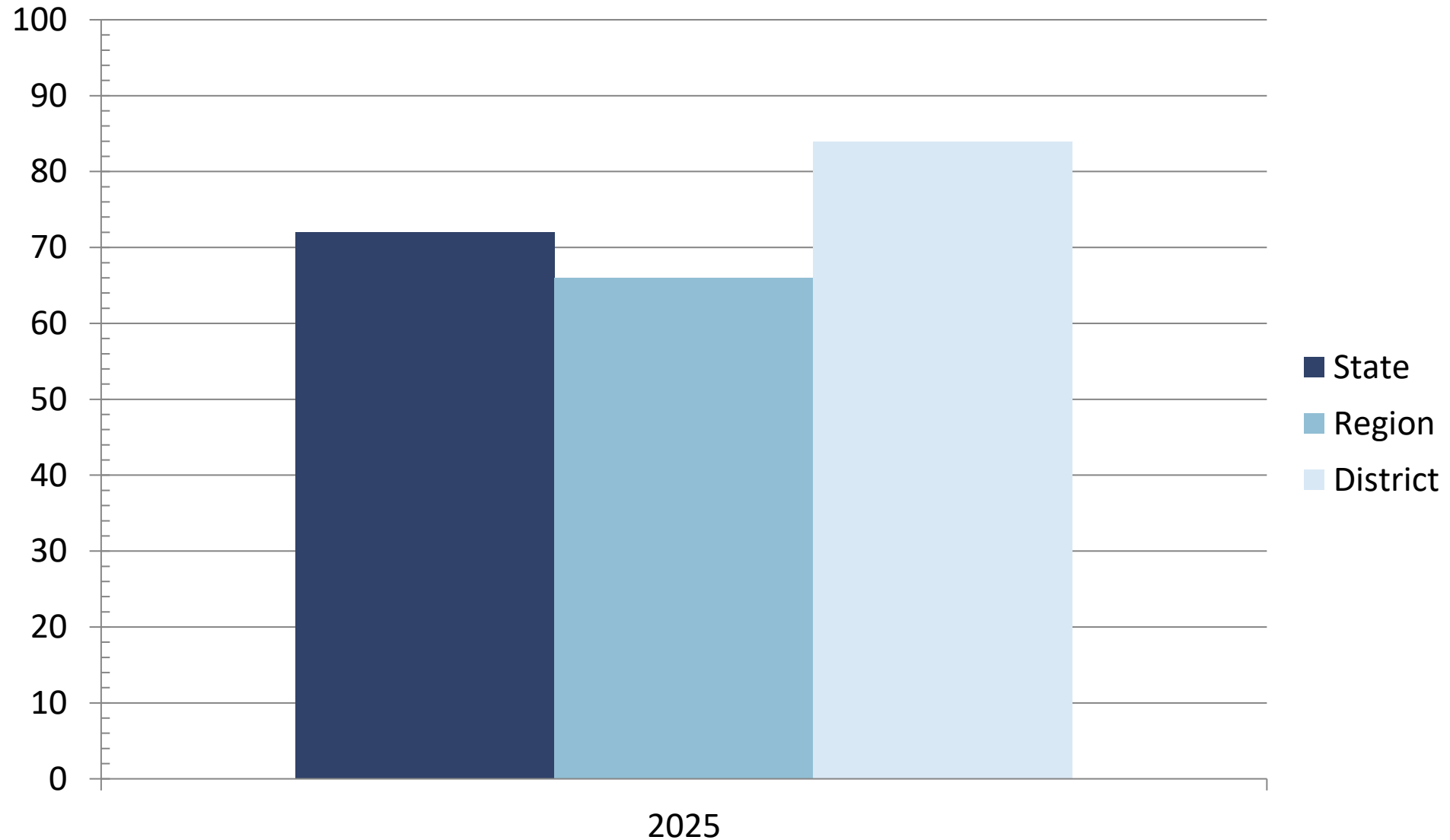
STAAR Percent at Approaches Grade Level or Above All Grades, ELA/Reading



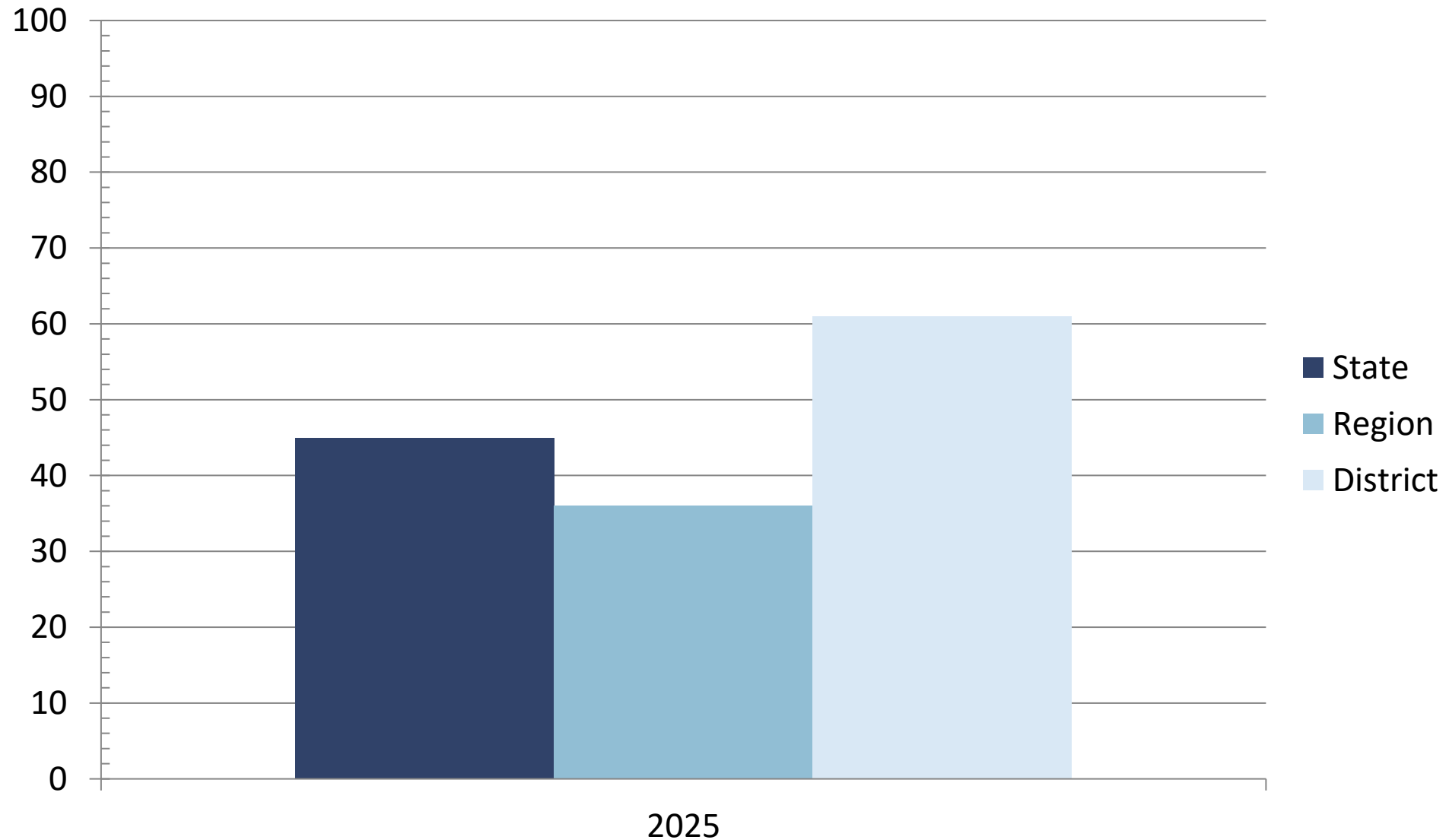

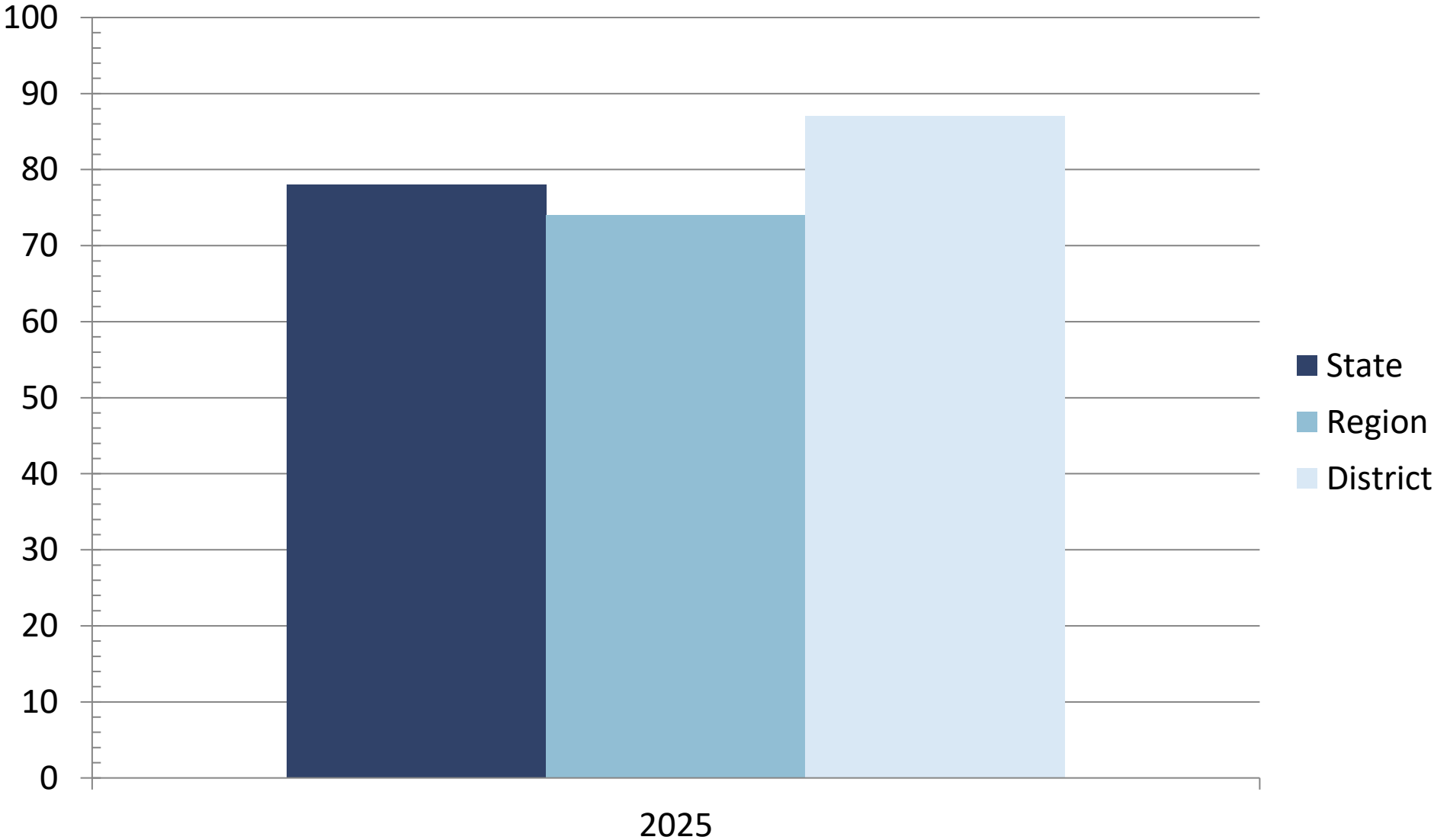

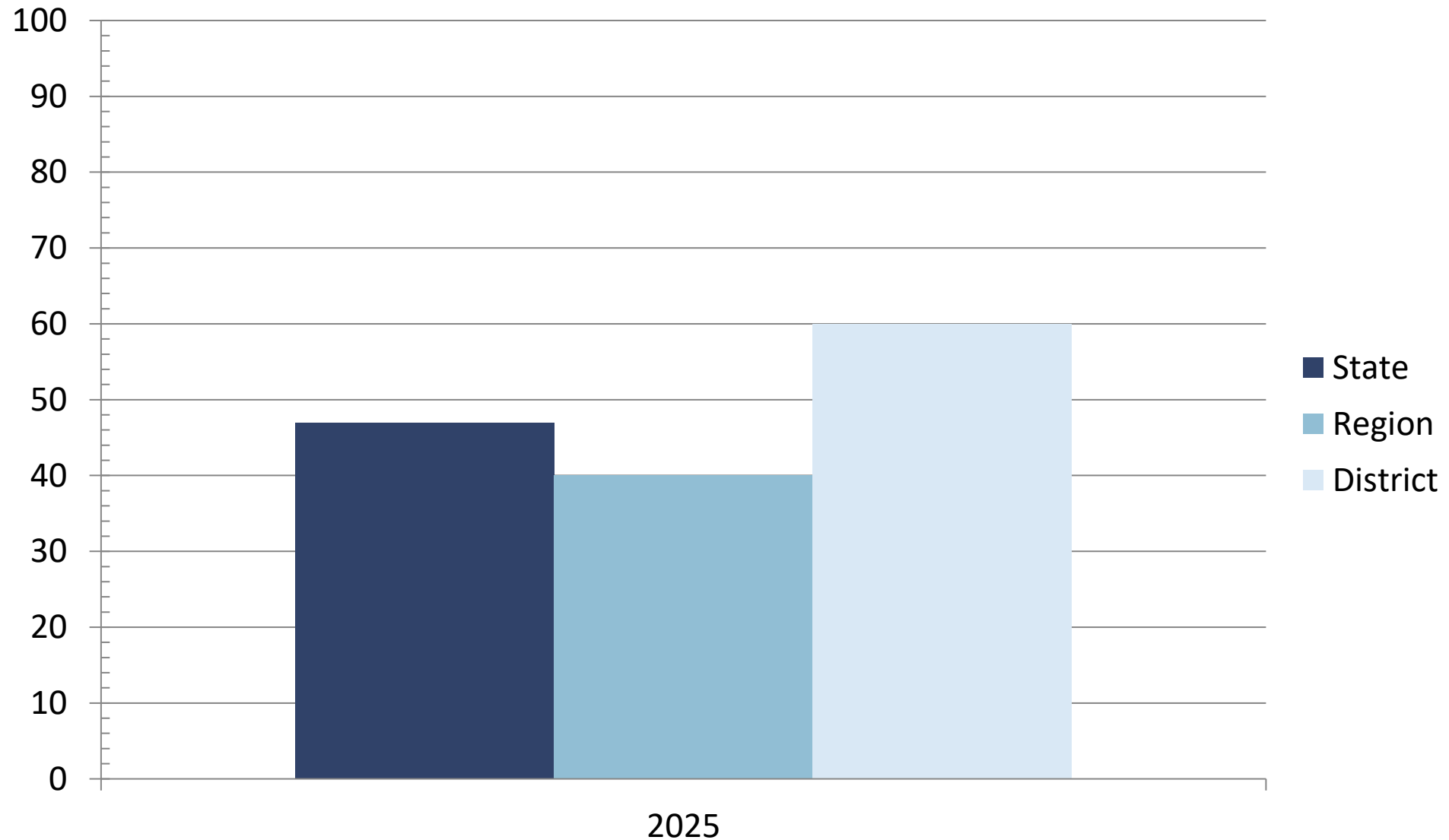

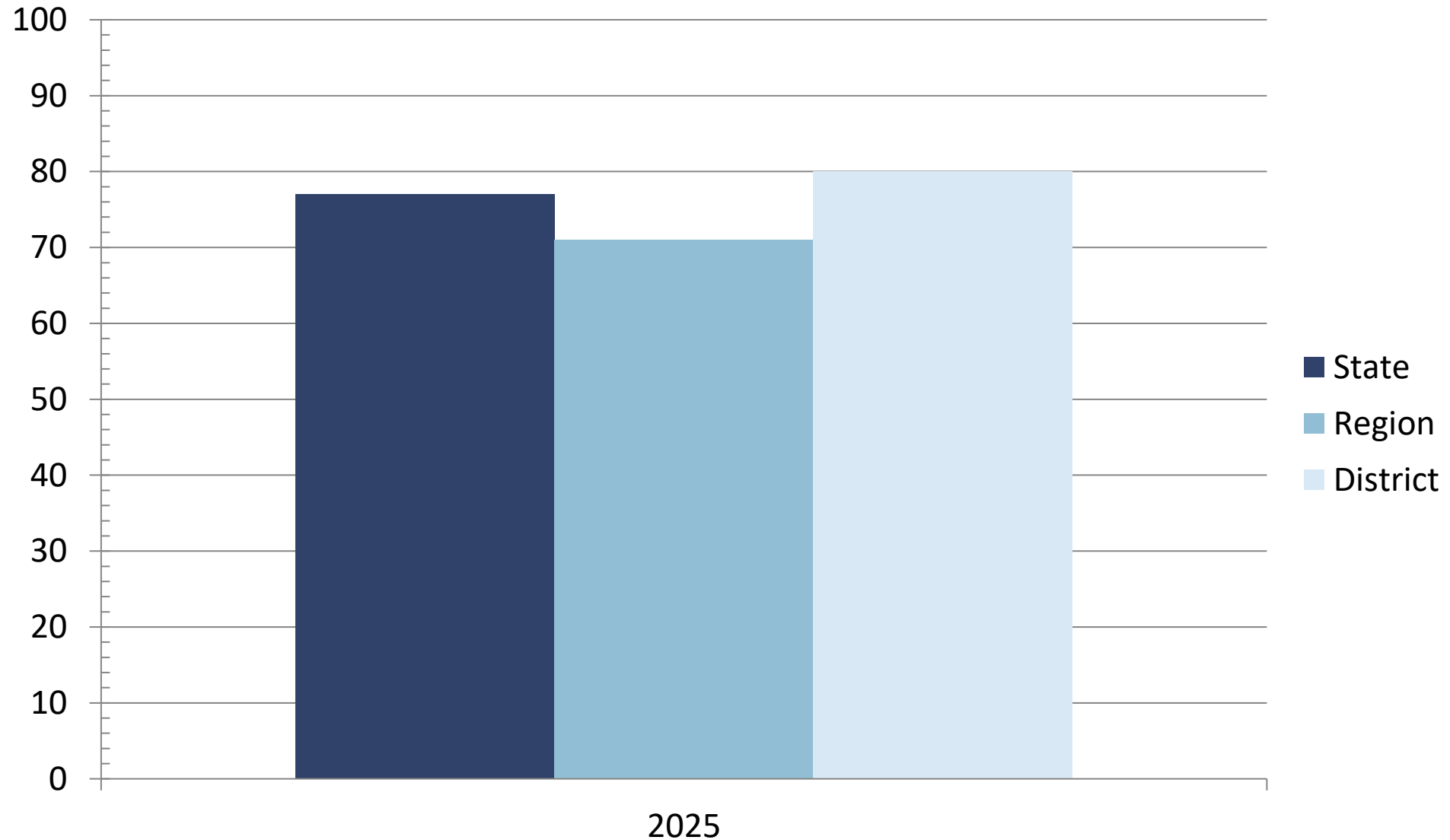

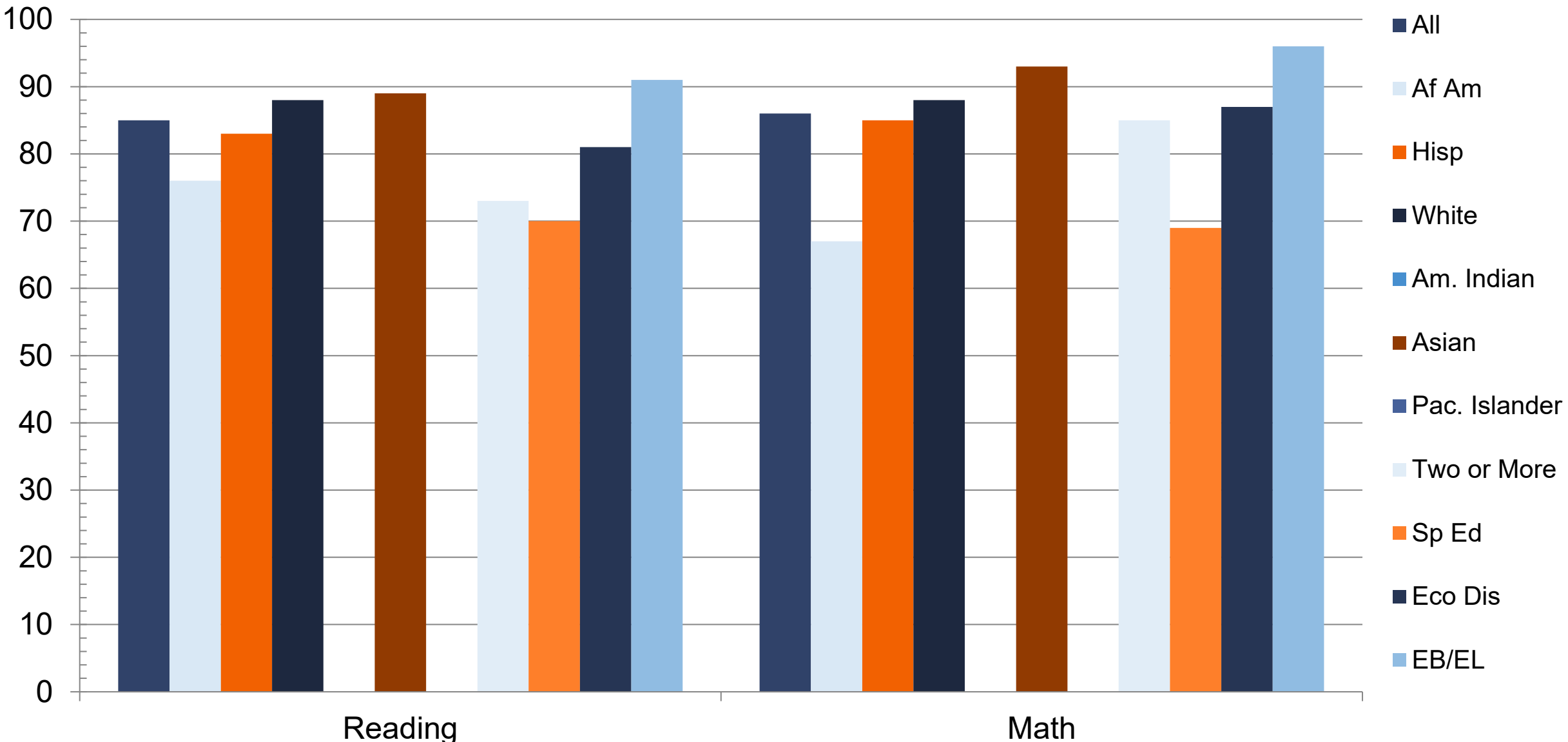

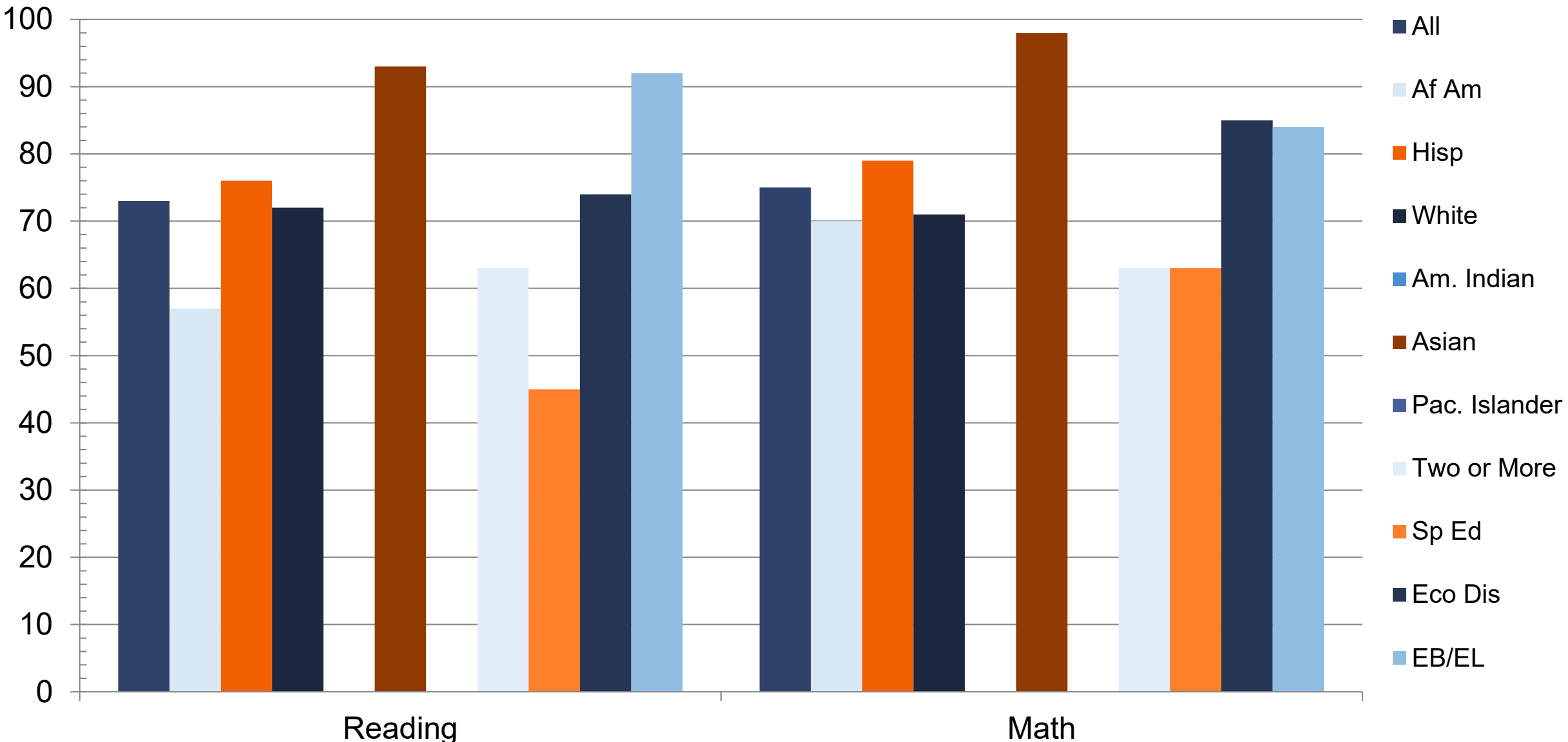

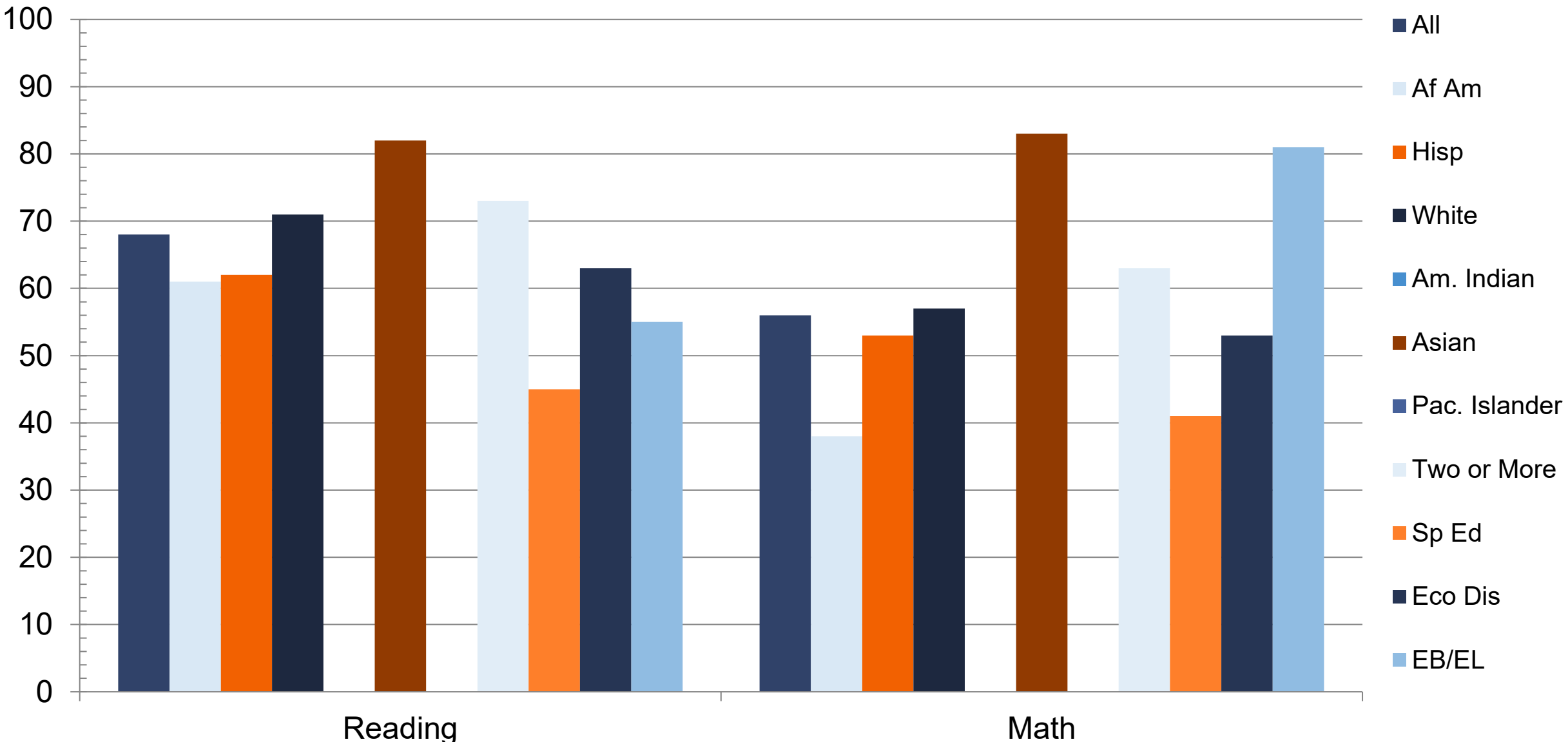

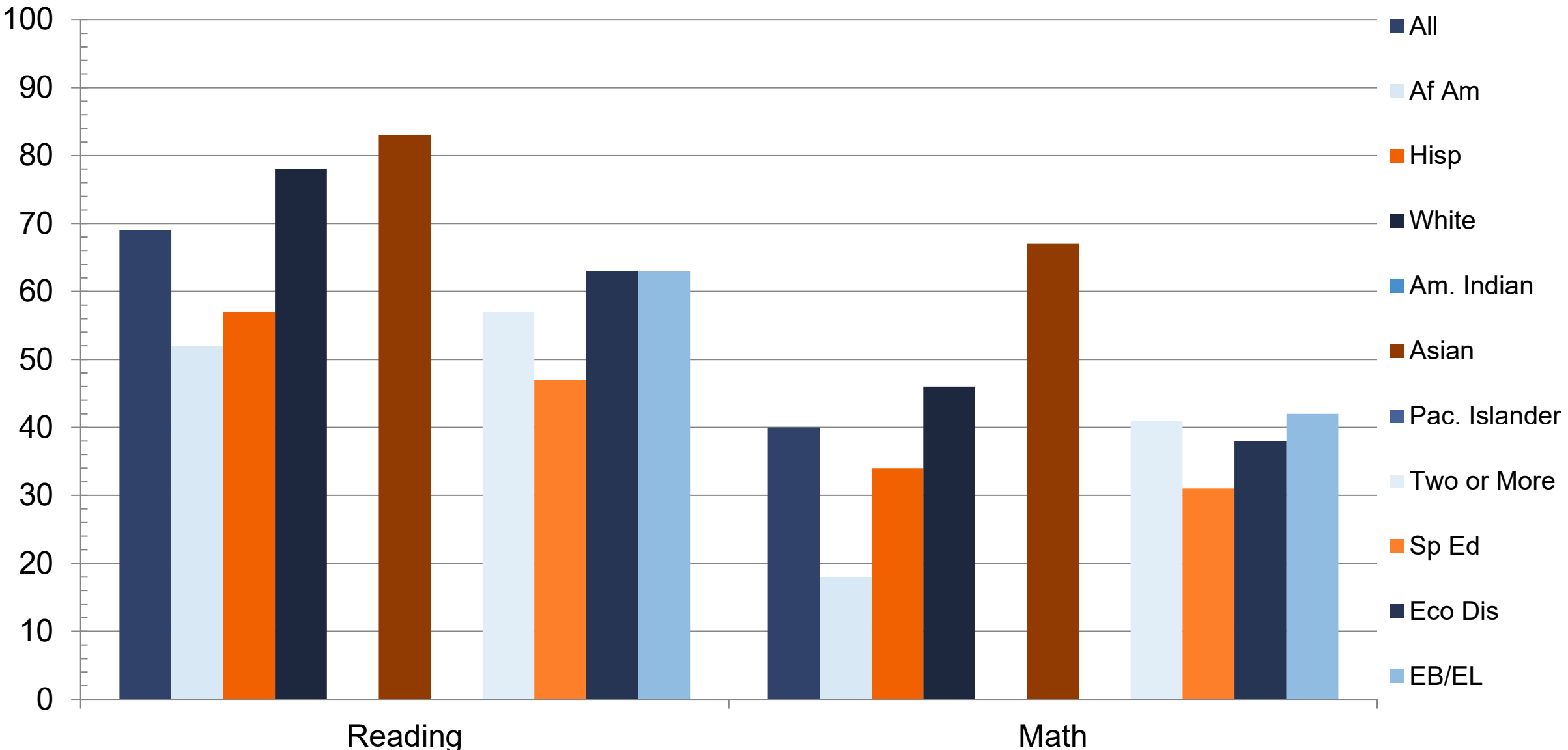

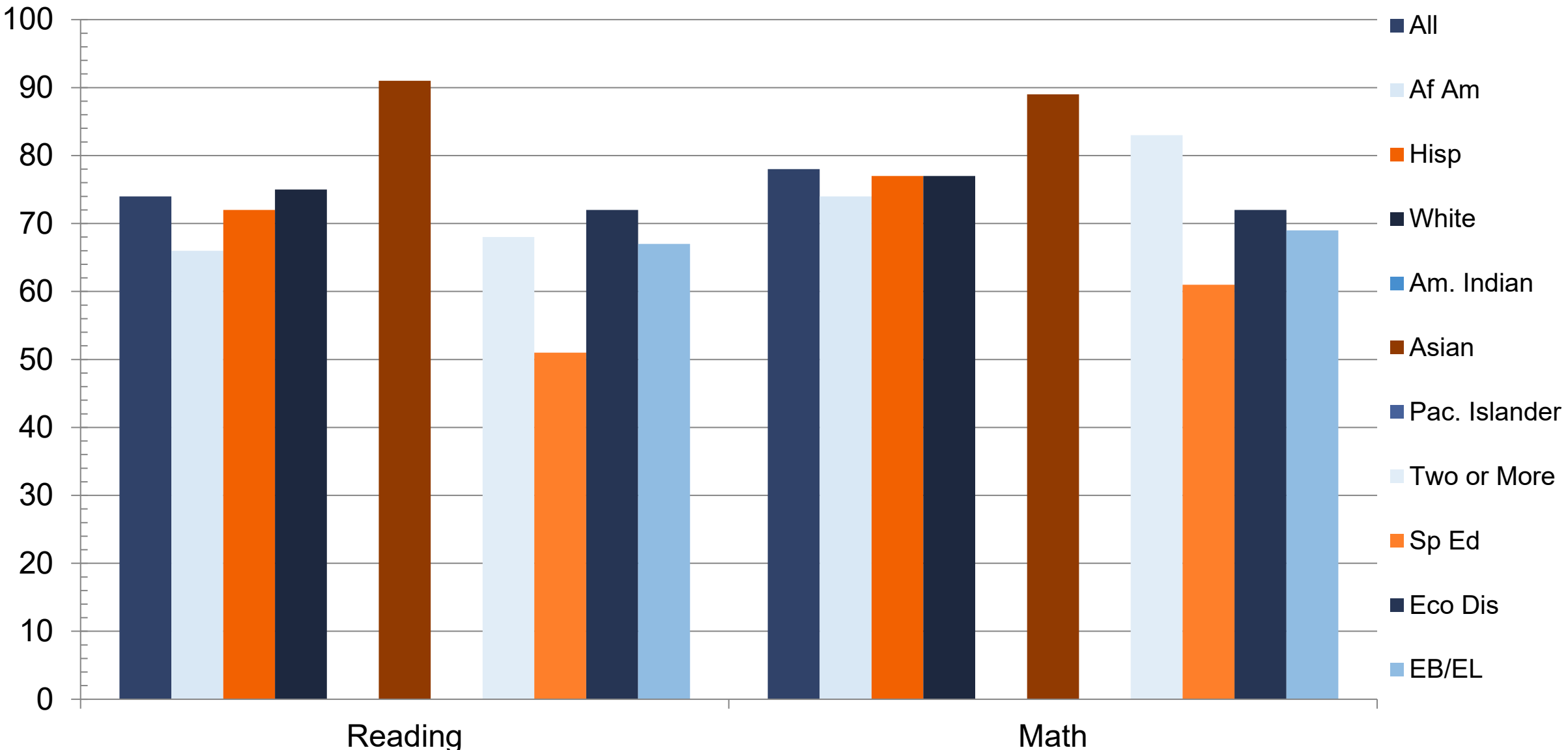

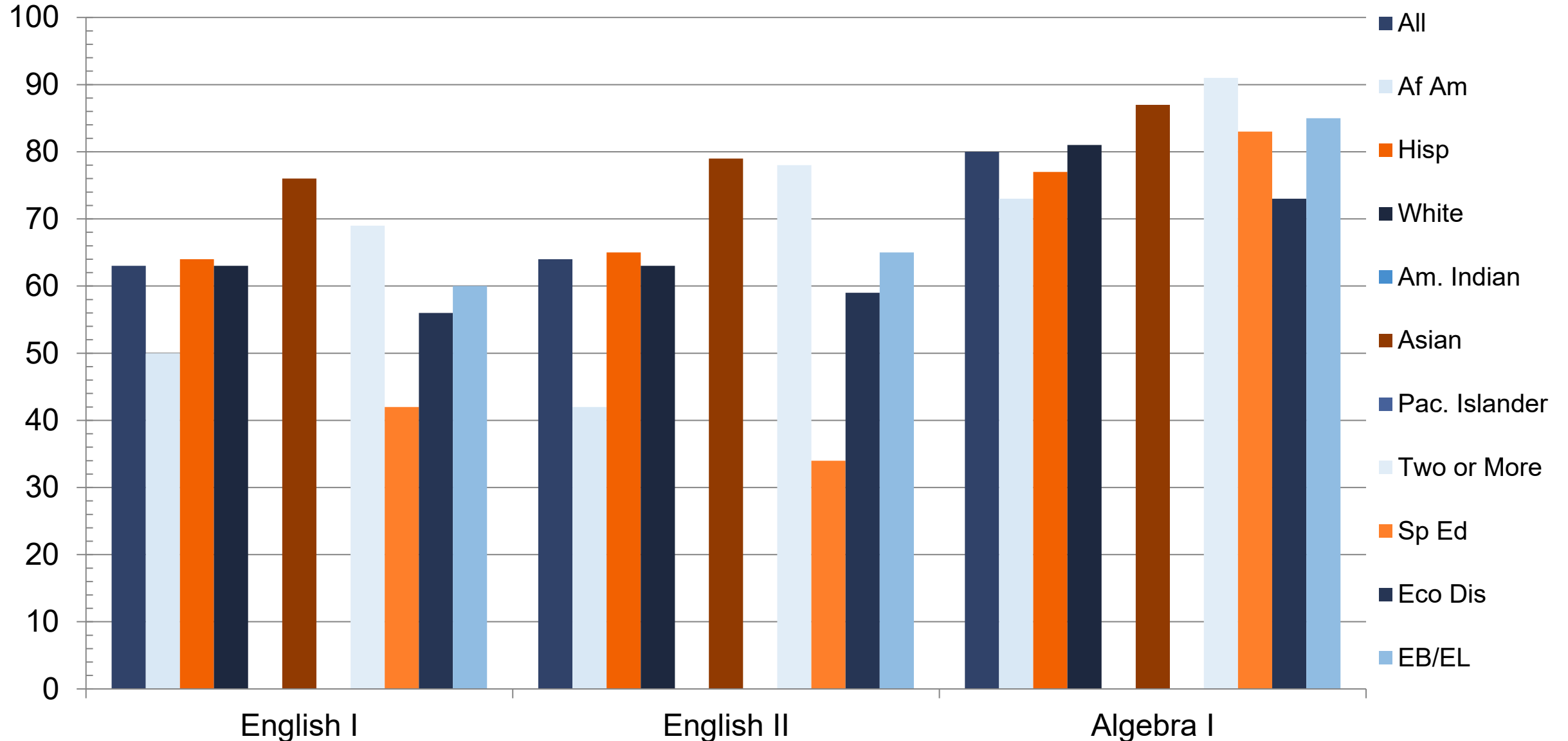

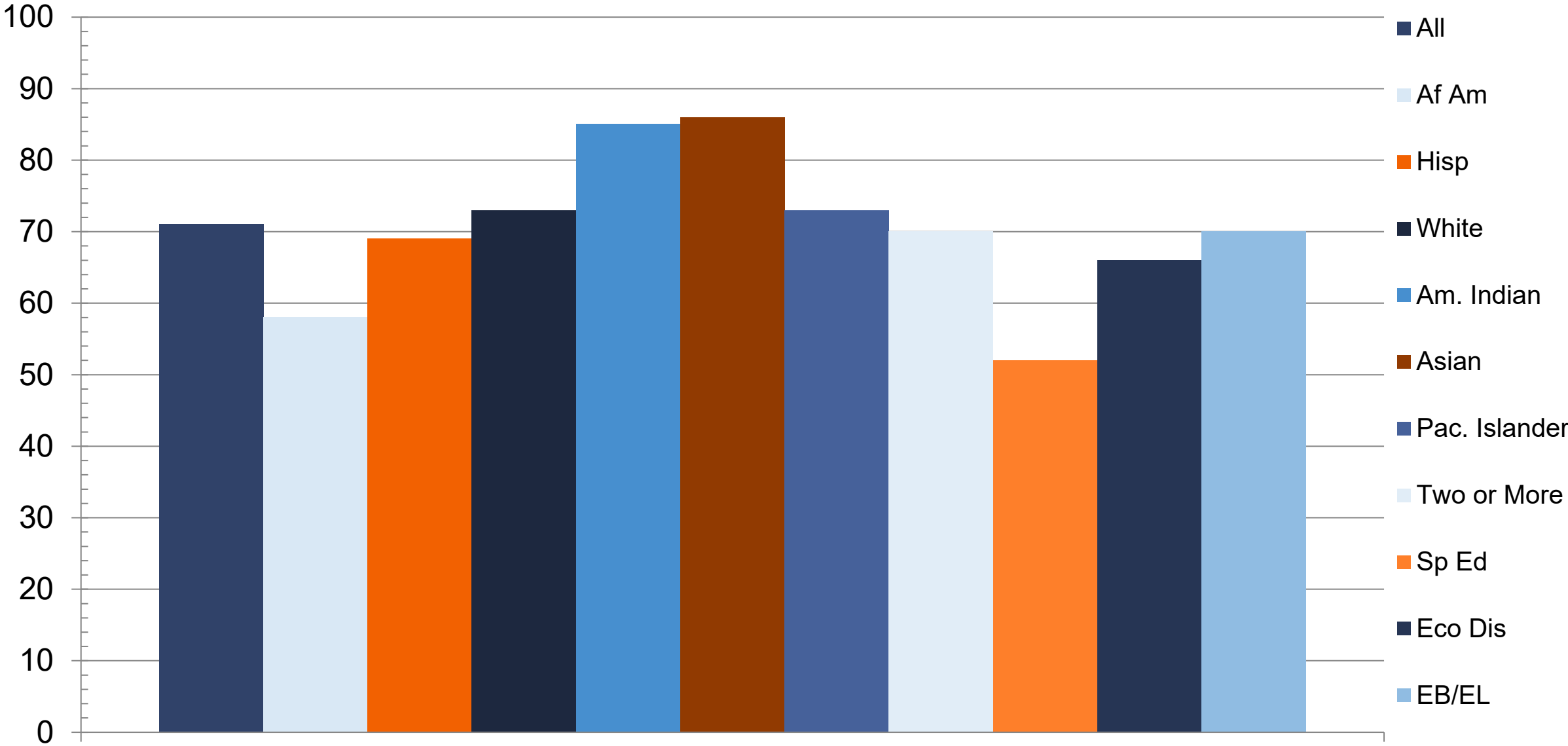

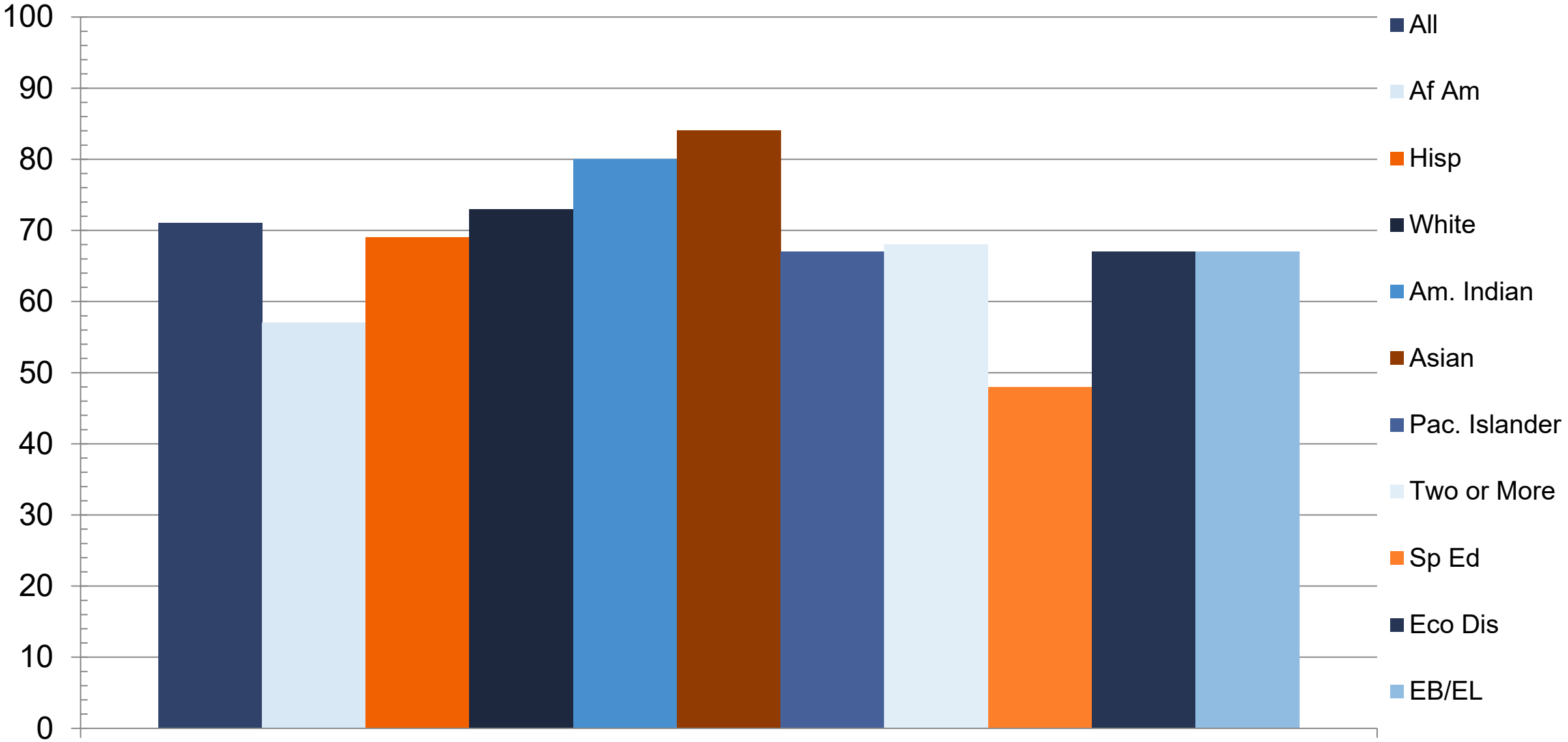

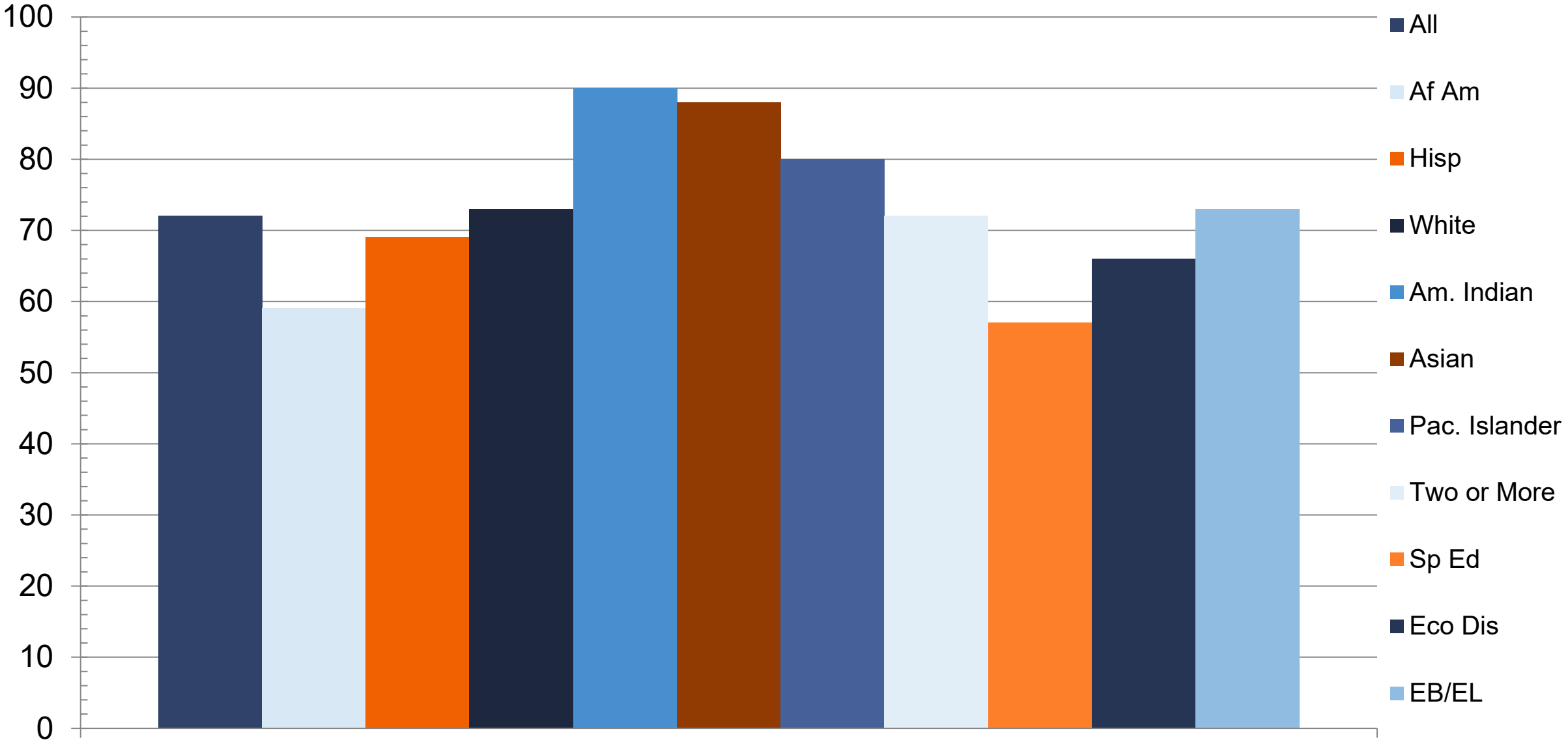

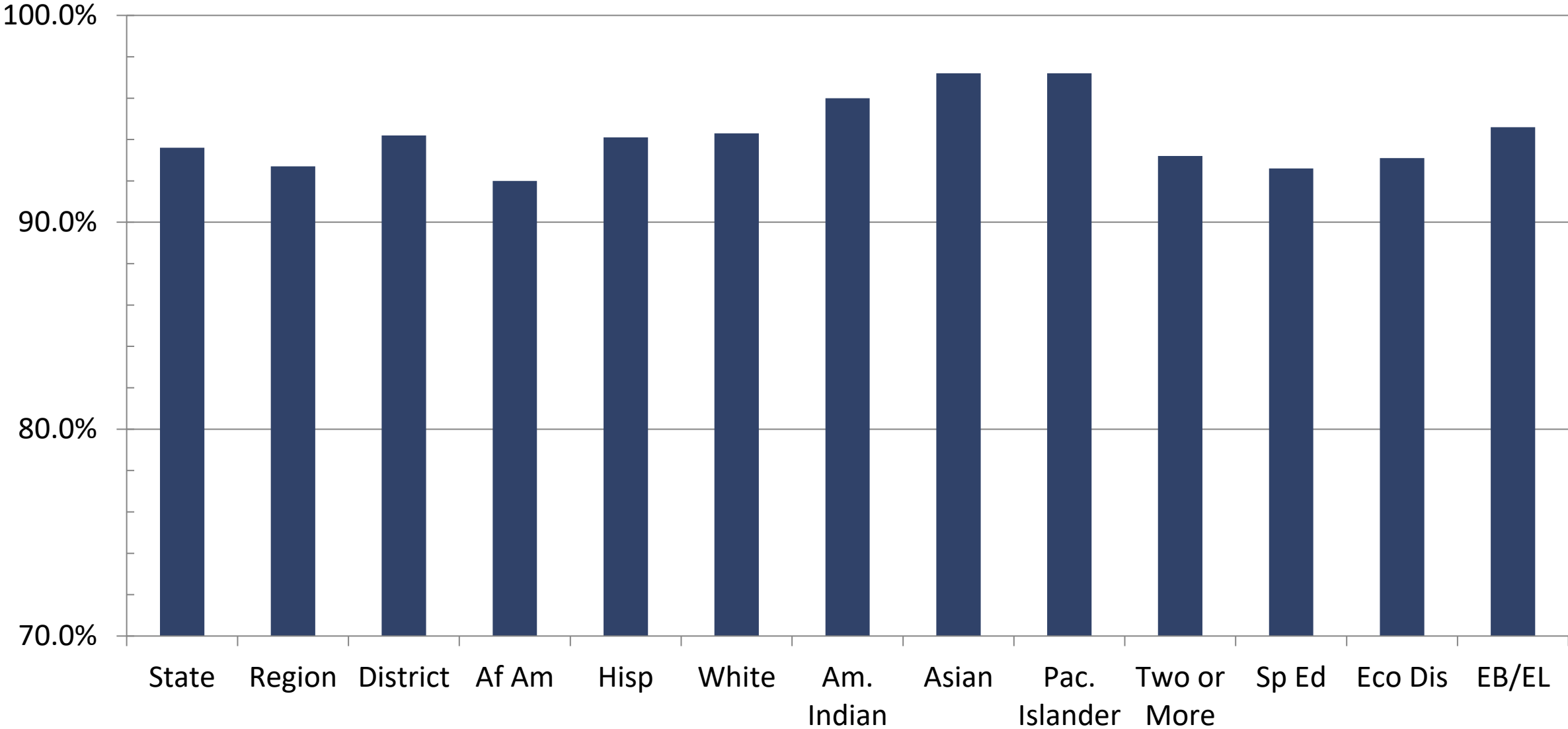

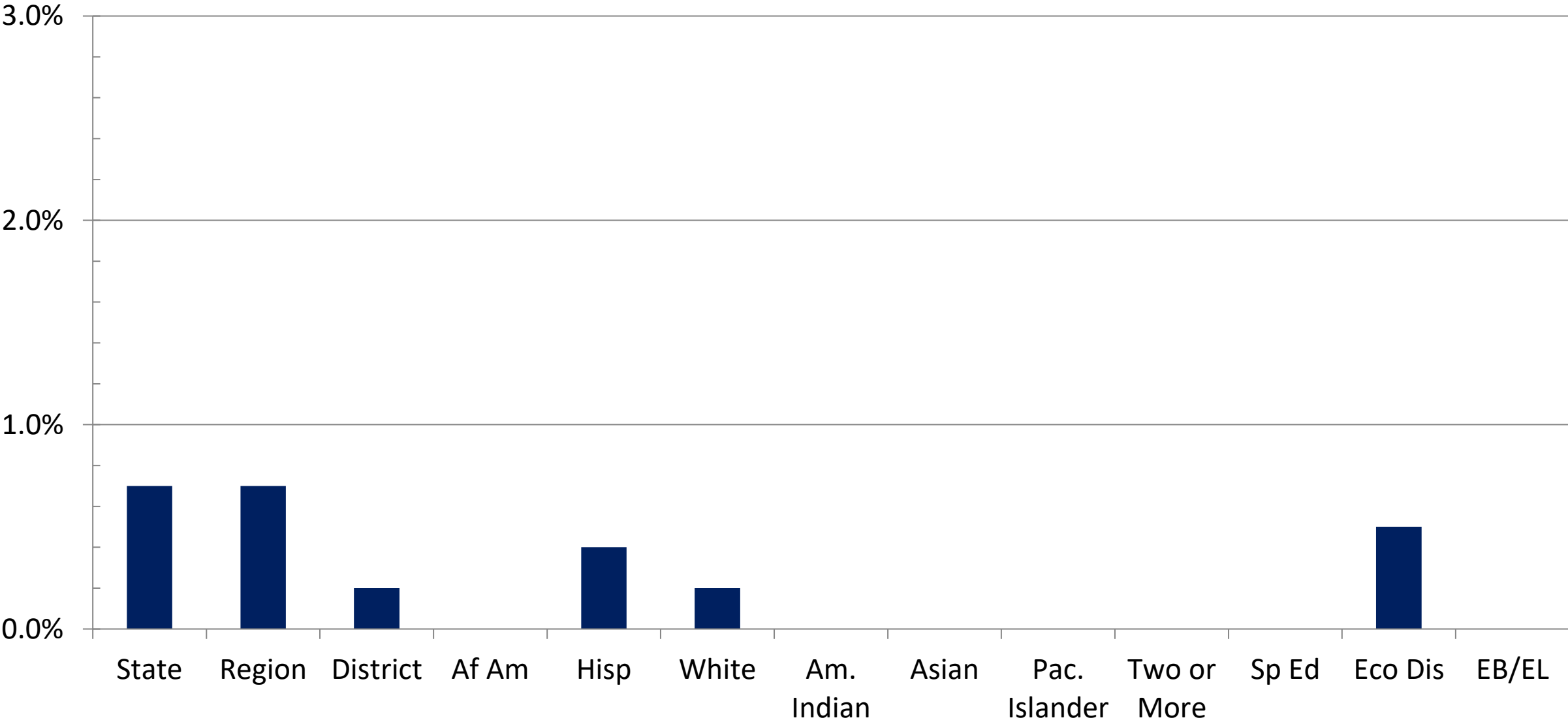

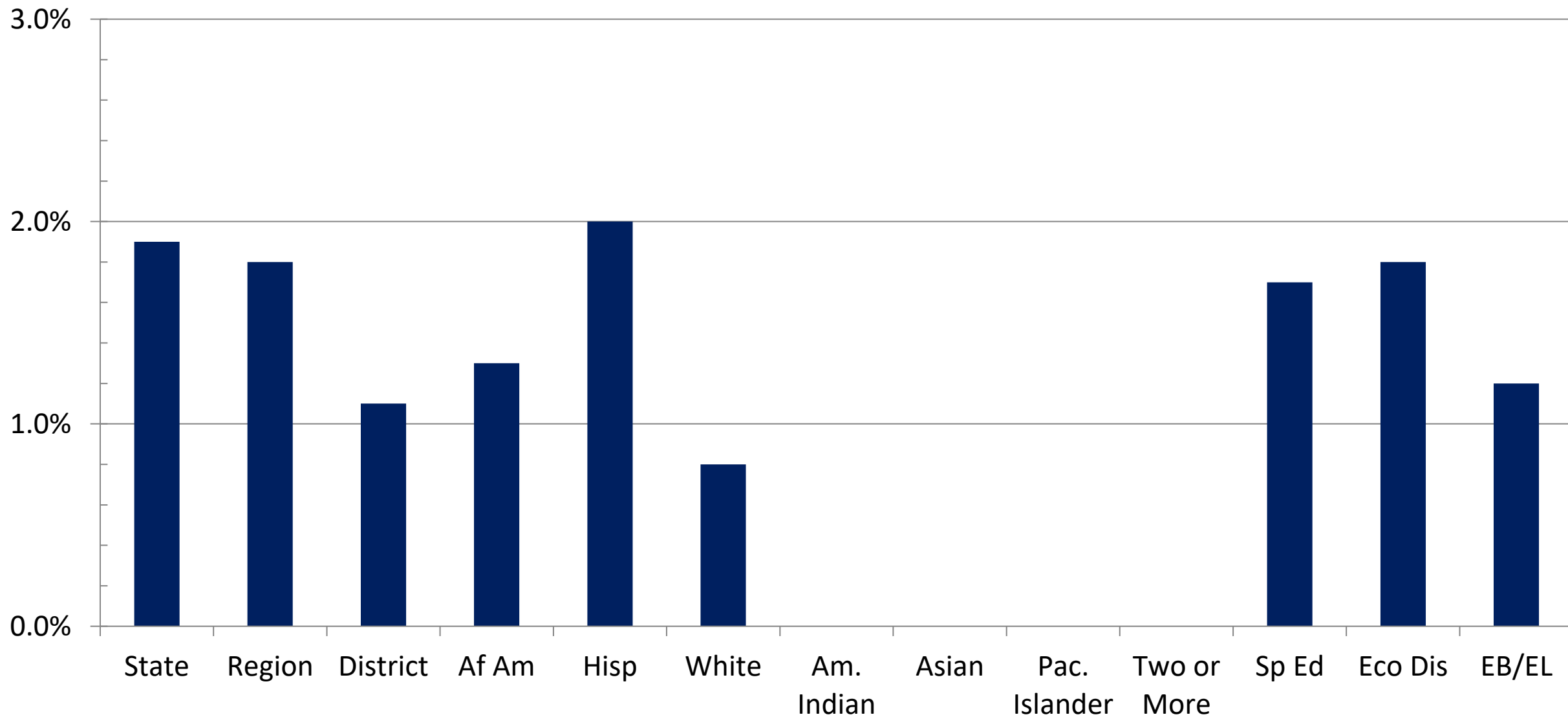
2025 Annual Dropout Rate (Grades 7-8)

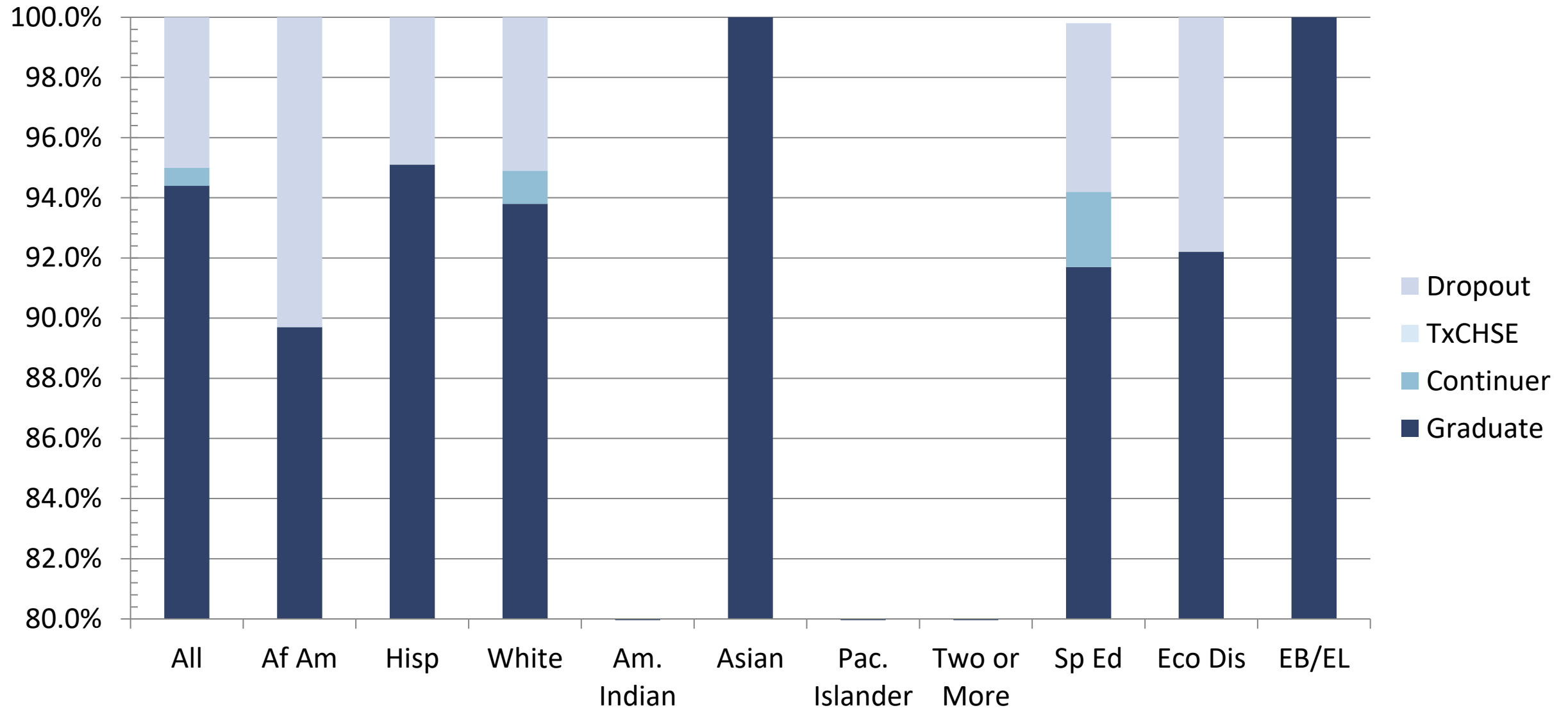

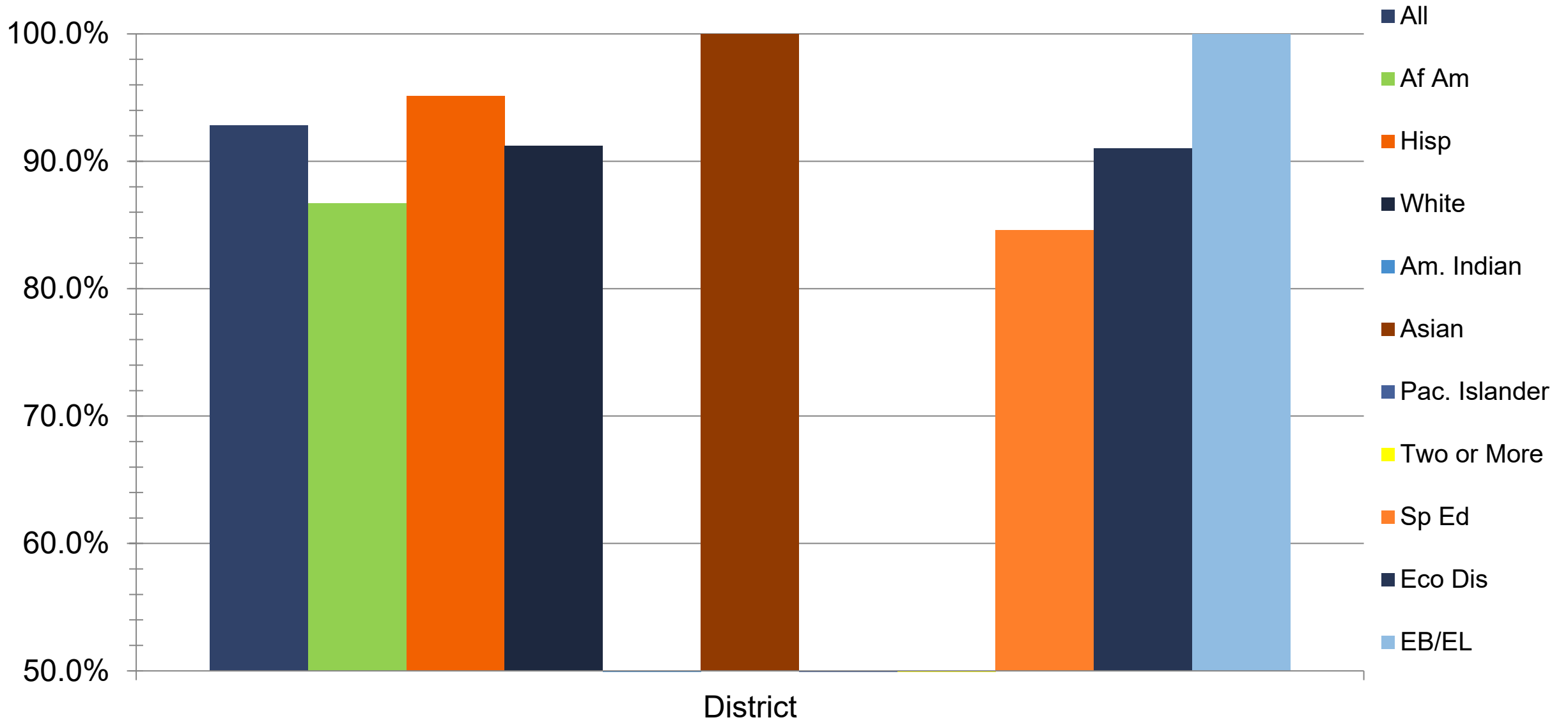
4-Year Longitudinal Graduation Rate (Grades 9-12)

Class of 2024 Cohort

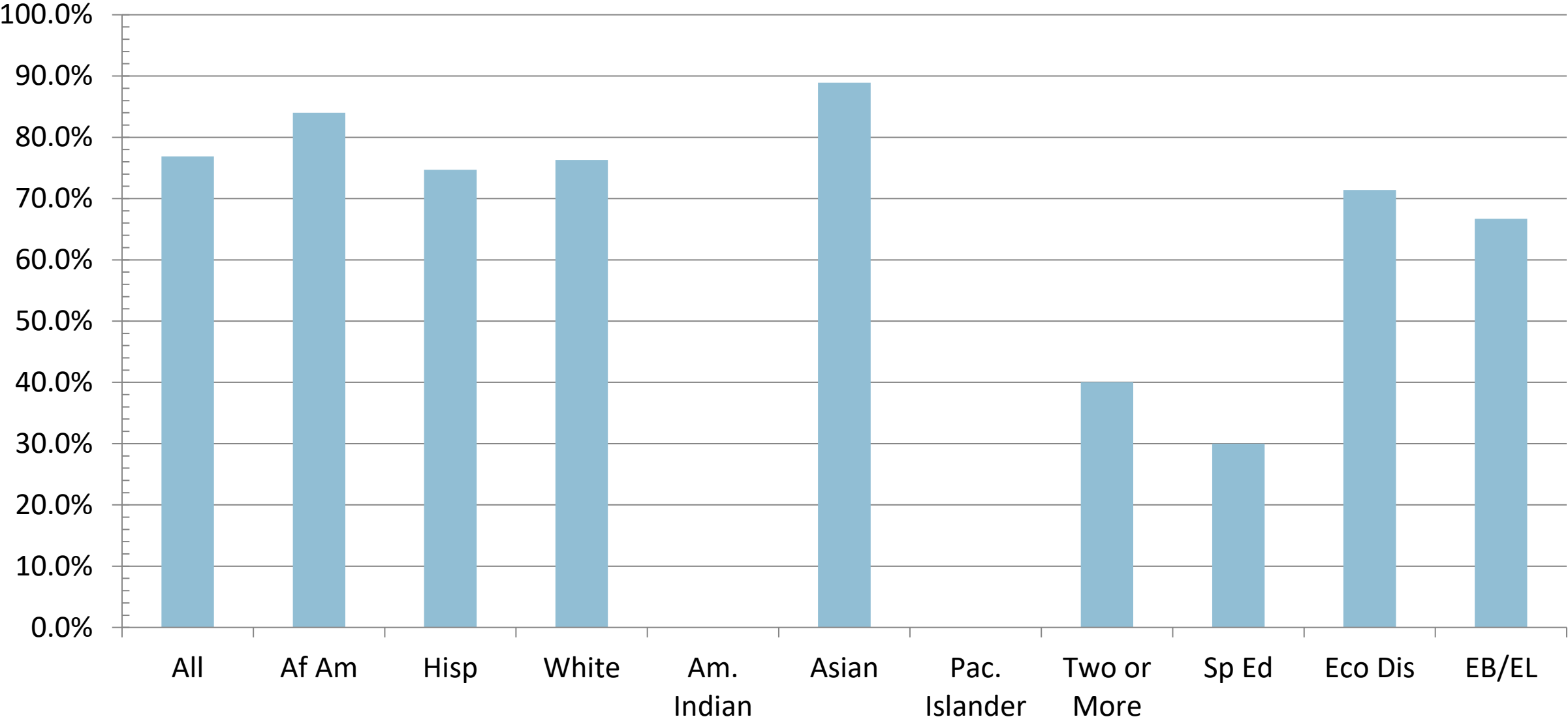


4-Year Federal Graduation Rate Without Exclusions (9-12)

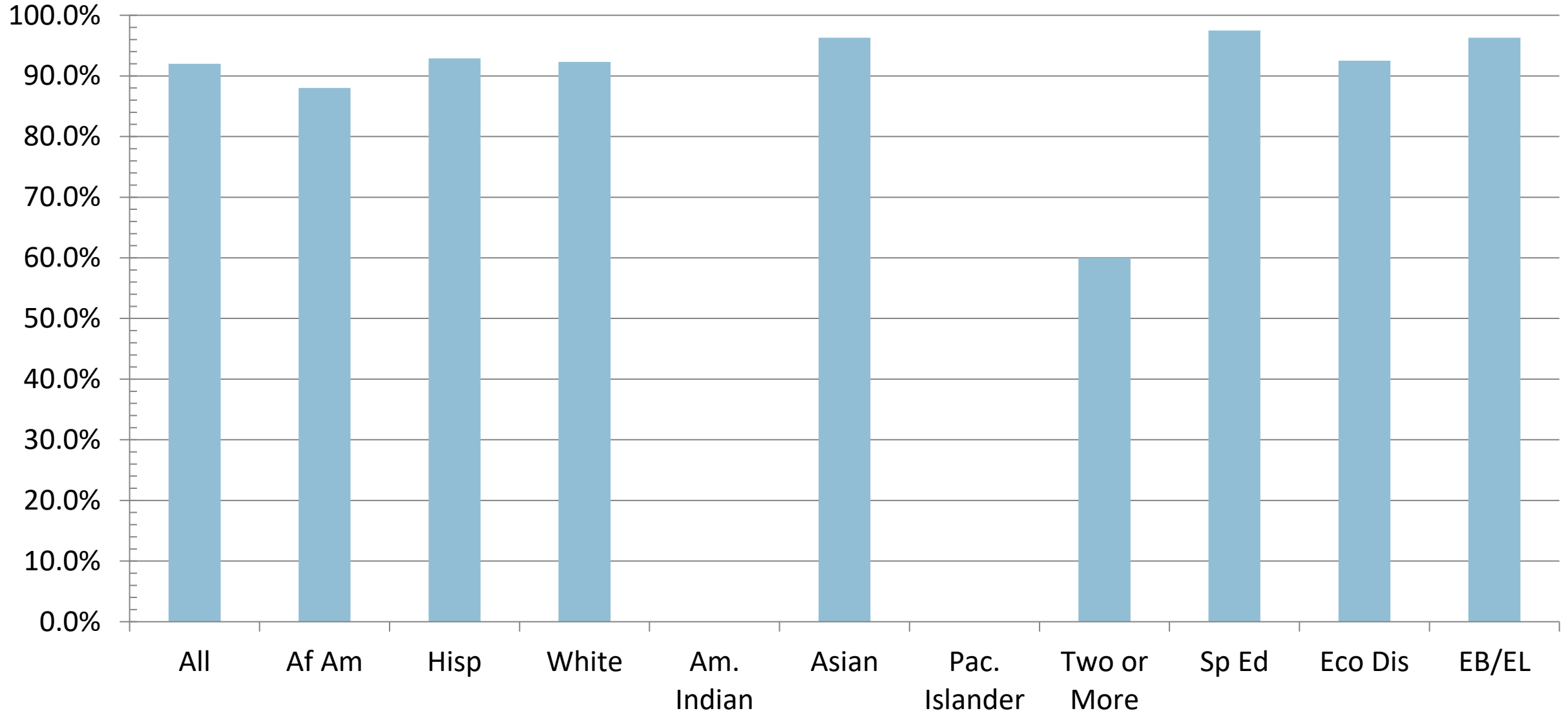

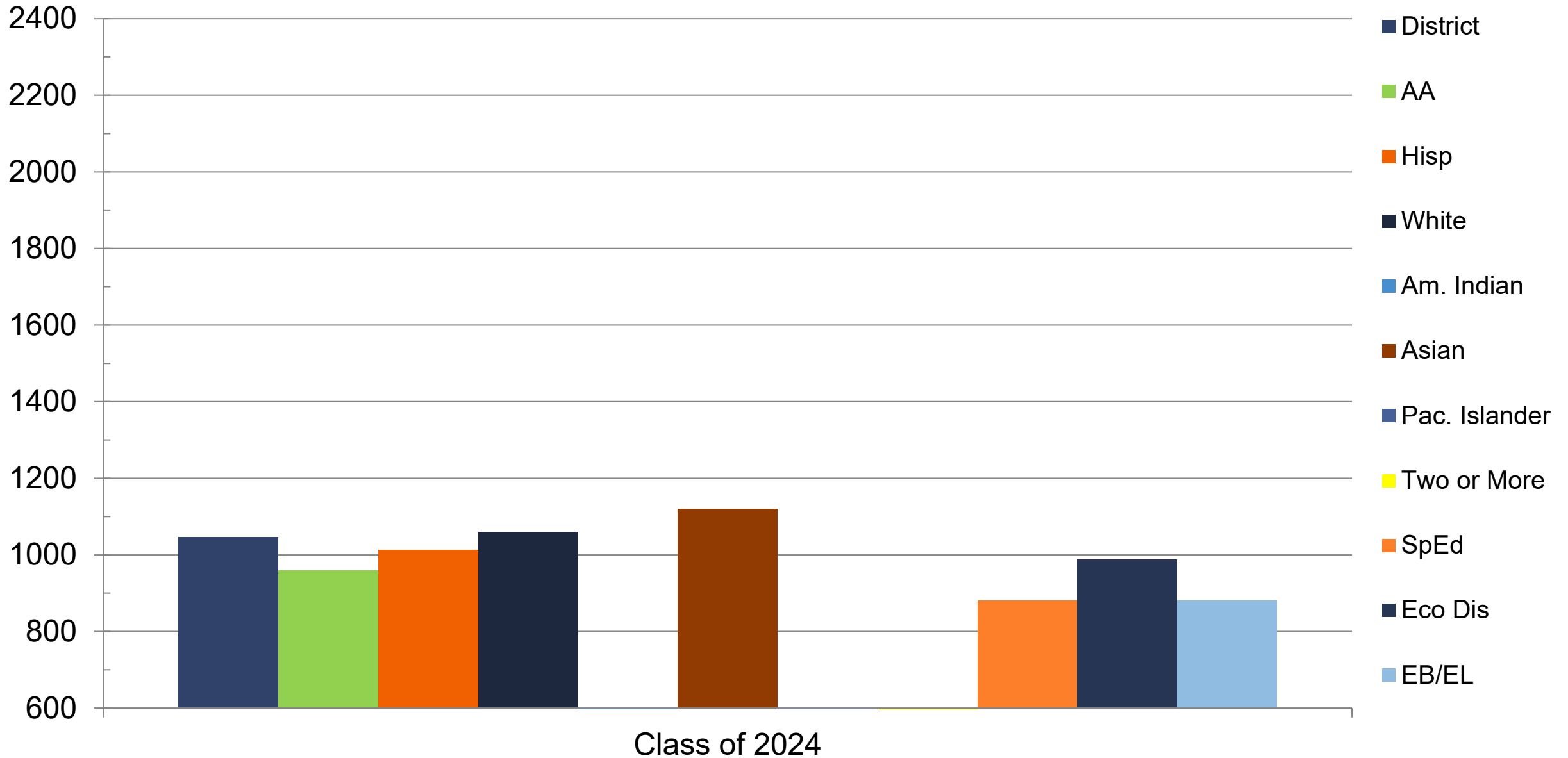
Class of 2024 College Ready Graduates



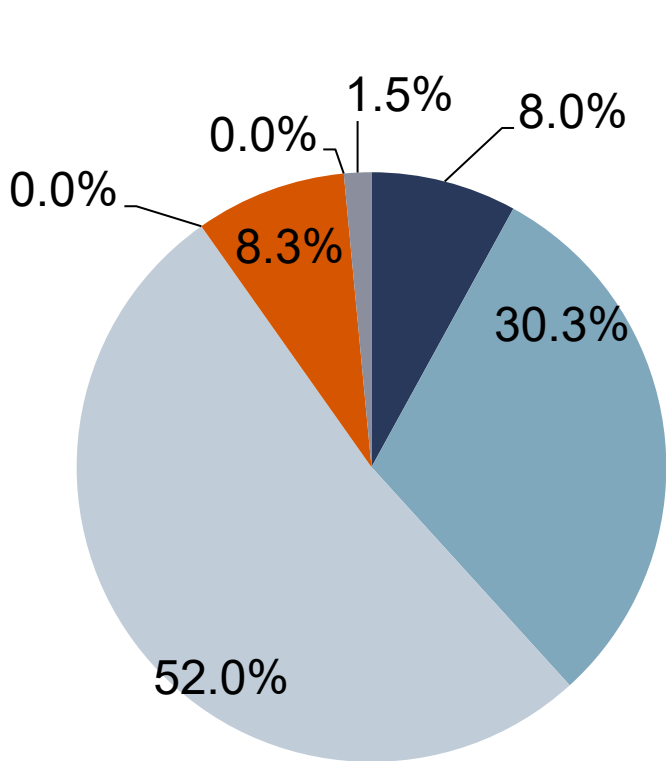
Class of 2024 Career or Military Ready Graduates



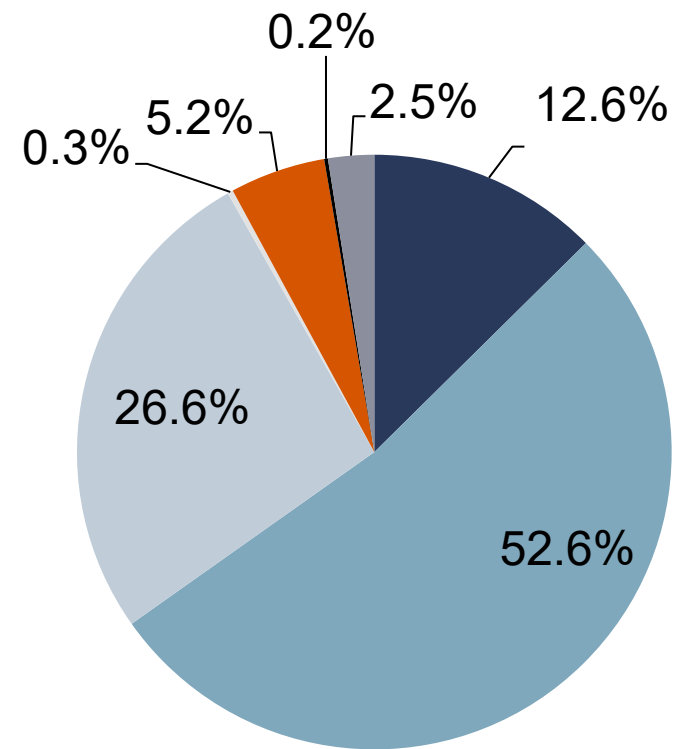
Average SAT Score, All Subjects

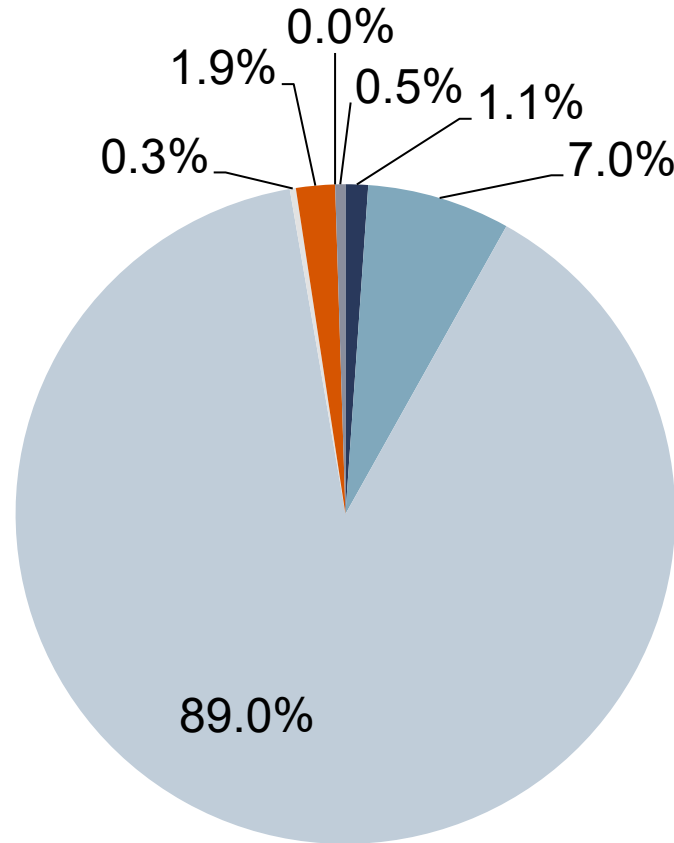

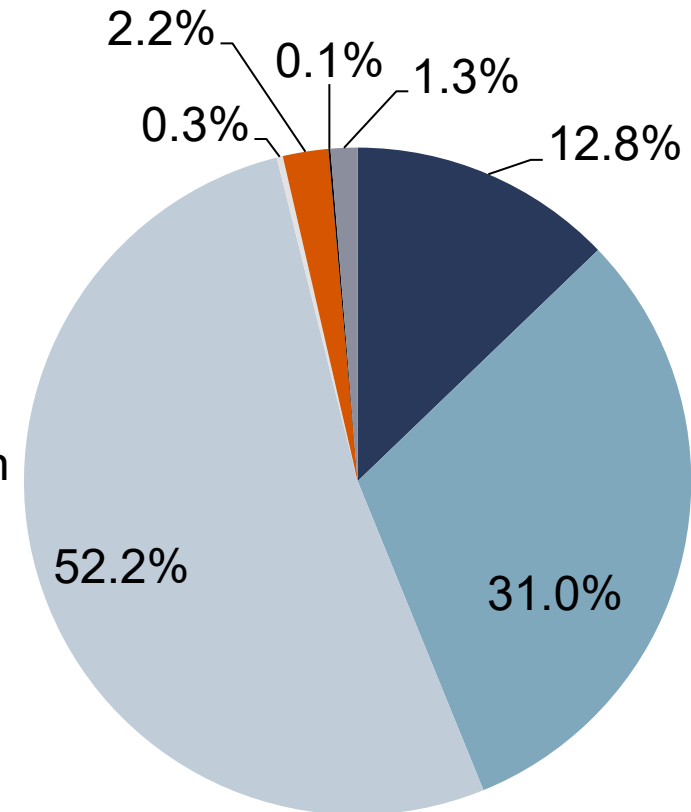

Violent and Criminal Incidents
